permits.

ZBA: Johnson said they did not have an October meeting. The next meeting will be

Library Report: Thompson relayed there is nothing new to report on for the library and the

October financials are attached. Our monthly meeting is this Wednesday at

5:30 p.m.

Senior Center Report: SThomas reported the monthly commodities were suspended due to the government shut down. On October 29th, we received an email saying we could have the distribution. We did and provided 84 people with food. The Senior Center will be closed for Veteran's Day.

Fire Authority Report: Bryan announced because tomorrow is Veteran's Day, the Fire Authority meeting will be on Wednesday. At the meeting we will be looking at approving a new fire policy that our attorney has reviewed. 12 smoke alarms were installed in September. We have hired three (3) new fire fighters. We have received the new self-contained breathing apparatus. Training is underway on those, and we are hoping to have them in service by December 1st.

Supervisor Rizk stated the Morning Brew with the BDA will start in January. The BDA is now subscribed to Grantwatch.com, a website that provides access to grants for non-profits and small businesses. They are working on the Pure Michigan Byway Project.

Parks and Rec: JThomas said they discussed the Zombie Walk in the park, and what they could improve next year. They will make some changes to make it bigger and better. We also discussed future projects, which could include putting benches in Clio Park or a new sign at Buell Lake. There is \$6,494.15 in the account.

Sports Complex Report: JThomas said they discussed new playground equipment and hope to have it installed before next season's events. Again, I want to thank Marlene Wilson and the Rotary for the generous donations. We are going to have a turkey trot.

Supervisor Report: Rizk communicated the committee for appointing a clerk will be making a recommendation at the December Board meeting. There are several committees that expire at the end of the year, and I will be contacting new members for committees shortly.
