## LEVY ELECTION RESOLUTION

A RESOLUTION CALLING A SPECIAL ELECTION TO BE HELD FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF JOINT SCHOOL DISTRICT NO. 331, MINIDOKA, CASSIA, JEROME AND LINCOLN COUNTIES, IDAHO THE PROPOSITION OF THE CERTIFICATION OF A SUPPLEMENTAL LEVY.

WHEREAS, the Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho (the "District") has determined it advisable to certify a Supplemental Levy for the purpose of financing all lawful expenses of maintaining and operating the schools and facilities of the District (the "Levy Project"), pursuant to chapter 8 of Title 33 of the Idaho Code and, in order to do so, desires to provide for the holding of a special election as required by said Chapter.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties as follows:

SECTION 1. That a Special Supplemental Levy Election (the "Levy Election") is hereby called to be held in the District on Tuesday, April 8, 2008 for the purpose of submitting to the qualified electors of the District the proposition set forth in the form of ballot appearing in Section 4 hereof.

SECTION 2. That the polls at the Levy Election shall open at the hour of 7:00 a.m. and remain open continuously until the hour of 8:00 p.m., at which time the polls will close.

SECTION 3. That all qualified electors of the District, eighteen (18) years of age or older, who have resided in the District for thirty (30) days preceding the Levy Election, who are registered or who register at the polls on the day of the Levy Election, as provided by law, are entitled to vote at the Levy Election.

SECTION 4. That the ballots to be used at the Levy Election shall be in substantially the following form:

QUESTION: Shall the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho be authorized and empowered to levy a Supplemental Levy in the amount of One Million Two Hundred Thousand and no/100 Dollars (\$1,200,000) per year for two (2) years, commencing with the fiscal year beginning July 1, 2008 and ending June 30, 2010, for the purpose of financing all lawful expenses of maintaining and operating the schools and facilities of the District; all as provided in the Resolution adopted by the Board of Trustees on April 8, 2008?

INSTRUCTIONS TO VOTERS: To vote on the preceding question, place an "X" in the square to the right of the words "IN FAVOR OF SUPPLEMENTAL LEVY OF \$1,200,000," or "AGAINST SUPPLEMENTAL LEVY OF \$1,200,000" according to the way you desire to vote on the question. All marks otherwise made are forbidden. All distinguishing marks are forbidden and make the ballot void. If you, by mistake or accident, mark, tear, deface, or otherwise mutilate this Ballot, return it to the Election Judges and obtain another Ballot.

SECTION 5. That the Clerk shall, in accordance with the provisions of § 34-2425 of the Idaho Code, cause sample ballots to be printed and distributed as provided by law and shall cause a facsimile, except as to size, of said sample ballot to be published in the MINIDOKA COUNTY NEWS, SOUTH IDAHO PRESS, and THE TIMES NEWS, newspapers published and/or of general circulation in the District, prior to the date of the Levy Election.

SECTION 6. That notice of the Levy Election shall be given by the Clerk by posting notice of said Levy Election not less than twenty-one days prior to the Levy Election in at least three places in the District, one of which places shall be at or near the main door of the administrative offices of the District, and by publication of the Notice of Special Supplemental Levy Election in the MINIDOKA COUNTY NEWS, SOUTH IDAHO PRESS, and THE TIMES NEWS, newspapers published and/or of general circulation within the District, once a week on the same day of three consecutive weeks prior to the election. The Notice of Special Supplemental Levy Election shall be in substantially the following form:

#### NOTICE OF SPECIAL SUPPLEMENTAL LEVY ELECTION

Pursuant to the laws of the State of Idaho and the Levy Election Resolution of the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho, adopted on February 21, 2008, notice is hereby given that a Special Supplemental Levy Election will be held in the District on April 8, 2008, beginning at the hour of 7:00 a.m. and closing at the hour of 8:00 p.m. on said date, for the purpose of taking a vote upon the following question, to wit:

QUESTION: Shall the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho be authorized and empowered to levy a Supplemental Levy in the amount of One Million Two Hundred Thousand and no/100 Dollars (\$1,200,000) per year for two (2) years, commencing with the fiscal year beginning July 1, 2008 and ending June 30, 2010, for the purpose of financing all lawful expenses of maintaining and operating the schools and facilities of the District; all as provided in the Resolution adopted by the Board of Trustees on February 21, 2008?

Notice is further given that only qualified electors of the District, eighteen (18) years of age or older, who have resided in the District for thirty (30) days preceding the Levy Election, who are registered or who register at the polls on the day of the Levy Election, as provided by law, are entitled to vote at said election.

Any registered elector of the District may make written application to the Clerk of the District in accordance with law for an absentee ballot, provided that an absentee ballot must be received by the Clerk at the above Absentee Address not later than 8:00 p.m. on the day of the election in order to be counted.

If at said Special Supplemental Levy Election a simple majority of the qualified registered electors eighteen (18) years of age or older voting at such election assent to the Supplemental Levy for the purpose of financing all lawful expenses of maintaining and operating the schools and facilities of the District, such levy shall be certified by the Board of Trustees of the District and shall become effective, as provided by the Idaho Code.

SECTION 7. That if at the Levy Election a simple majority of the qualified registered electors of the District, eighteen (18) years of age or older who have resided in the District for thirty (30) days voting thereat assent to the authorization of such levy, the Supplemental Levy shall be certified by the Board of Trustees of the District and shall become effective in accordance with the provisions of § 33-802, Idaho Code. Such levy will provide funds for acquisition and construction of the Levy Project.

SECTION 8. The polling places set forth in Section 6 hereof are hereby designated as the polling places for the precincts.

SECTION 9. That the Board of Trustees of the District, acting as the board of canvassers, shall meet on Wednesday, April 9, 2008 at 6:30 a.m., after receiving all returns from the board of election, and shall canvass the election returns of all precincts within the District and shall examine and make a statement of all questions for which votes were cast, including the total number of affirmative or negative votes cast for any question voted on, and shall enter the results of the election as reflected in such statement in the minutes of the Board of Trustees.
