Project Description

Hillsdale ISD has an existing conference/meeting area that they would like to install some A/V for presentations and meetings. One of the hurdles we are dealing with are the acoustics of the room and sound reflection. Without being able to add carpeting which is usually the most affordable way for improving acoustics in a room. The best route would be to start with replacing all ceiling speakers that will shorten the reflection distance. Basically meaning that the volume can be much lower because the distance traveled to the listener is shorter.

- Mount the existing projector on the pillars/Poll along with cabling.
- Carter's will provide electrical at the needed locations
- Install a wall-mounted rack at the location of the current speaker wire and microphone termination.
- Replace all 12 ceiling speakers with the upgraded model giving better vocals.
- Set up customer provided laptop for presentations via HDMI
- Set up a new lapel microphone system.
- Set up a new handheld microphone system.
- Configure acoustics of the room with riverbanks software, optimizing sound quality for the room.
- The system is fully expandable and also can be removed and relocated in the future if needed other than the in ceiling speakers.
- Includes gold warranty 3 years on equipment and parts.

Project Terms

All equipment is warrantied for 1 year and we guarantee our labor free of any defects for 90 days. If service is required, Carter's will provided service within 24 hours on all commercial projects. (exclusions for warranty fire damage, water damage, lightening damage or internet outages). Any changes to this proposal, either verbal or in writing, will become part of the contract, and will be added or subtracted in the final bill upon completion. Any equipment the customer provides outside CCS, that results in incompatibility or faulty, may result in additional charges, due to the time it takes to make the system work. (or additional equipment needed). The standard \$65/hr rate will apply.

In regards to DVR viewing offline via computer: If there is any communication problems with the customers computer not being able to link to the webpage due to browser security or any security settings. If the computer needs to be updated or reconfigured and customer is unable to make these changes on their computer. Carters will do what we can over the phone to instruct the customer but sometimes this does not workout. Carter's will need to have the computer to make those changes. Additional charges may apply.

Responsibilities of customer regarding cable/satellite/internet: if equipment is not activated, and calls need to be made for activation, (for service connection), additional charges will apply. Any pre-wire jobs do not include termination of outlets. Cabinetry must be adequate to fit this equipment and drawings must be submitted for our approval. Media cabinets must provide adequate ventilation to ventilate the heat of electronic equipment. Quiet fans may be needed/purchased for ventilation. In some cases drywall may need to be opened. Any drywall or paint repair required is not the responsibility of CCS, but we can provide a reputable subcontractor.

Audio and video manufacturers regularly update their products offerings. In our efforts to procure the latest technology, we reserve the right to provide the most up to date models at the time of installation. In retrofit applications, existing wiring may not be compatible with today's equipment. Therefore, equipment and labor needed for the project may change. (Not to exceed our standard hourly rate of \$65pr man hr plus any additional equipment needed.)

Terms: Upon acceptance, prepaid discounts only apply if job is paid in full. All equipment remains the property of CCS, Inc. until installation and equipment charges have been paid in full.
