**ALIGNS TO BOARD GOAL(S):** Parents/Community – Parents and members of the community will have meaningful opportunities to participate in the educational processes of the Aledo ISD.

### **BACKGROUND INFORMATION:**

- As stated in Board Policy BBB (LEGAL), the Board of Trustees consists of seven members serving terms of three years, with elections held annually.
- The terms of one-third of the Board Members, or as near to one-third as possible, expire each year.
- Election of Board Members is by position or place in accordance with Texas law.

### **ADMINISTRATIVE CONSIDERATIONS:**

- An Order of Election was approved by the School Board on February 18 for a Board of Trustees Election to be held on May 11, 2013.
- The deadline for interested parties to file an application as a candidate, or a write-in candidate, for the May 11, 2013 election has passed with only two applications received.
- Applications were received from incumbents Steve Bartley, Place 4, and Bobby J Rigues, Place 5.
- Texas Election Code Sections 2.051, 2.052, and 2.053(a), (b), and (c) provide for declaring unopposed candidates elected to office and cancellation of an election.
- The following documents, Cancellation of Trustee Election on May 11, 2013 and Certification of Unopposed Candidates for Other Political Subdivisions (Not County) have been prepared in accordance with these provisions.
- Although the Board of Trustee election is being cancelled, the Aledo ISD Administration Building will still serve as a voting site for the May 11 election.
