Sheryl shared the attached letter addressed to Board President Spatz on June 3, 2014. Immediately upon receipt, I reached out to Phil Hutchinson at Altamanu who then contacted vendors listed as references by Kenneth Company. I noted that in the attached letter, with accompanying citations, the time period was from 2005 through 2010.

When I reviewed the reference list and saw Michael Grandy listed from the Park District of Oak Park, I reached out and spoke directly with him on Thursday, June 5. Mike indicated that The Kenneth Company is one of his preferred vendors with work being done from 2009 through 2012, that this company has always complied with the prevailing wage laws and many times is high on their bid submissions.

Phil Hutchinson contacted Kaneland School District 302 who indicated that "The Kenneth Company installed a playground for them last year (2013), had no issues with them, would recommend hiring them again and had no issues with the prevailing wage payment." He further spoke with Ryan Veldman from Tinley Park Park District who also indicated "that they had no issues with Kenneth on recent projects (2013) and that they provided all required payroll documentation and certifications for prevailing wages." Phil received a return telephone call from Frank Stec at the Village of Orland Park who indicated that they "also had a good experience with Kenneth, no issues to report."

I am attaching the notice received, along with the reference list provided to us at the time the bids were received. I am continuing to recommend award of a contract to Kenneth Company, in the total amount of \$242,911, as supported by the landscape architect, Altamanu, Inc., and further supported by substantiation that projects conducted since 2010 have been in compliance with prevailing wage laws. This item will return to the Board for formal approval at its June 24, 2014 meeting.

(Act). This letter constitutes a Notice of First Violation and is issued by IDOL pursuant to Section 11a of the Act, and the Prevailing Wage Hearing Procedures, 56 Ill. Adm. Code 100.

The Department has determined that the above named addressees have violated the Act in regard to the above referenced project by the following conduct:

The above named addressee's have violated Section 3 of the Act by failing to pay the prevailing rate of wages of Will & Cook Counties to its workers. The Department has determined that the total amount of wages by which workers were underpaid was \$3,365.49. This amount represents the difference between actual wages paid and the amount required under the Act. The assessed 20% statutory penalty amounted to \$673.09. The total amount assessed against the contractor on this project was \$4,038.58.

If the Department determines that the above named addressees have committed a second violation of the Act within two (2) years of the date of a Notice of First Violation, they will be subject to a summary debarment for a period of two (2) years, during which time it will be unable to perform work on any public work project. Upon issuance of Notice of Second Violation, they have the right to request a hearing to contest the violations underlying the Notices of First and Second Violations, pursuant to Section 11a of the Act and the Prevalling Wage Hearing Procedures. A hearing is NOT available solely upon Notice of First Violation.
