- Reimburseable FTE (Reimb. FTE): An estimate of the Total FTE that will be reimbursed by the State.

- Headcount: The number of individual students who maintained enrolled in the selected term.

- Enrollment: The number of courses students enrolled in and also maintained enrollment.

- Sections: The number of course sections offered.
