(Rates not ready publish on August 7<sup>th</sup>.)</b></p>	<p><b>REGULAR BOARD MEETING</b></p> <p><b>Consider proposed tax rate for 2014-15 AND OTHER AGENDA ITEMS</b></p>	<p><b>Draft budget and discuss and decide tax levy Board adopts proposed notice date with proposed tax rate.</b></p> <p>*POST NOTICE IN PAPER: "Notice of Public Meeting to Discuss Budget and Proposed Tax Rate" (MUST APPEAR IN PAPER 10-30 DAYS BEFORE THE MEETING.) TAKE NOTICE TO PAPER 7/31/14. WILL APPEAR (NLT) IN POST SIGNAL 8/7/14.</p>
<p>Earliest day for hearing Monday, August 18<sup>th</sup> if notice is ready to appear in paper by August 7<sup>th</sup>. A good date, for flexibility is Wednesday August 27<sup>th</sup>. We must have the proposed budget prepared by August 20, 2014.</p>		
<p>Wednesday AUGUST 27</p> <p><b>Meeting date is within 10-30 days limit of when the notice was published in the Post Signal</b></p>	<p><b>BOARD MEETING TO DISCUSS BUDGET AND PROPOSED TAX RATE HEARING FOR BUDGET AND TAX RATE</b></p>	<p><b>POST AGENDA AND DISCUSS BUDGET AND TAX RATE FOR THE 2014-15 SCHOOL YEAR.</b></p> <p>Public meeting to discuss budget and proposed tax rate. At least 10 days but not more than 30. This date fulfills the requirement of the 10-30 day law.</p>
<p><b>Wednesday AUGUST 27</b></p> <p><b>NOTICE APPEARED IN PAPER ON 8/7/14</b></p>	<p><b>OTHER AGENDA ITEMS AT THE SAME BOARD MEETING</b></p>	<p><b>AGENDA ITEMS: HEARING</b></p> <ol style="list-style-type: none"> <li>1. Approve Certified Tax Roll</li> <li>2. Vote on the budget 2014-15</li> <li>3. Adopt the tax rate by ordinance</li> <li>4. Amend Budget for 2013-14 school year</li> <li>5. Other items as needed</li> </ol>
<p>At the public meeting: any taxpayer in the district may be present and participate in the meeting. The budget and tax rate may be adopted at the public meeting held to discuss them and hear public comments according to Education Code Section 44.004. The budget must be adopted before the tax rate. <b>*THE BUDGET MUST BE PREPARED NO LATER THAN AUGUST 20TH AND NO MONEY CAN BE SPENT FOR THE 2014-15 SCHOOL YEAR UNTIL IT IS ADOPTED.</b></p> <p><b>**THE TAX RATE SHOULD BE ADOPTED BEFORE SEPTEMBER 1, 2014.</b></p>
