

RESOLUTION OF THE BOARD REGARDING HAZARDOUS TRAFFIC CONDITIONS

WHEREAS, Education Code 42.155(d) allows the Board of Trustees of the Midway Independent School District to obtain supplemental state funding for transporting regular, otherwise ineligible students who live within two miles of their school but who would be subject to hazardous traffic conditions if they walked to school;

WHEREAS, the TEA handbook on School Transportation Allotments requires the Board to adopt language providing the definition of hazardous traffic conditions applicable to the District and identifying the specific hazardous areas for which such funding is requested;

WHEREAS, the Board acknowledges the Education Code 42.155(d) provisions stating that a hazardous condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, an uncontrolled major traffic artery, an industrial or commercial area, or another comparable condition;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of the Midway Independent School District has determined that a hazardous condition exists because there is no walkway provided where students must walk along or cross:

1. Middle Bosque River bridge
2. State Highway 84
3. State Highway 1695 (Hewitt Drive)
4. Speegleville Road
5. State Highway 2113 (Spring Valley Road)
6. Chapel Road southwest of the Chapel Road/Meadows Mountain Drive intersection.
7. Ritchie Road
8. Alamosa, Chama Drive, and Romana Circle
9. West Warren St west of Polo Park Dr to Ritchie Road

And the Board of Trustees of Midway Independent School District has identified the following specific hazardous areas in which such conditions exist:

1. All streets north of the Middle Bosque River bridge within two miles of River Valley Intermediate, where River Valley Intermediate is the home campus.
2. All streets north of State Highway 84 within two miles of Midway Middle School, where Midway Middle School is the home campus.
3. All streets north of State Highway 84 within two miles of Midway High School, where Midway High School is the home campus.
4. All streets south of State Highway 84 within two miles of Woodway Elementary, where Woodway Elementary is the home campus.
5. All streets south of State Highway 84 within two miles of South Bosque Elementary, where South Bosque Elementary is the home campus.
6. All streets east of State Highway 1695 (Hewitt Drive) within two miles of Castleman Creek Elementary, where Castleman Creek Elementary is the home campus.

7. All streets north of State Highway 84 within two miles of River Valley Intermediate from Speegleville Road west to Bosque Lane, north to Oak Road where River Valley is the home campus.
8. All streets north of State Highway 84 within two miles of River Valley Intermediate east of Speegleville Road and north to Sunnydale Drive where River Valley is the home campus.
9. All streets within two miles of River Valley Intermediate in Hidden Valley One housing development and Hidden Valley Two housing development where River Valley is the home campus.
10. All streets within two miles of Spring Valley Elementary and south of State Highway 2113 where the home campus is Spring Valley Elementary.
11. All streets within two miles of Spring Valley Elementary and north of State Highway 2113 and east of First St or east of Old Temple Road where the home campus is Spring Valley Elementary.
12. The streets of Black Diamond Circle and Keswick Drive are within two miles of Spring Valley Elementary and where the home campus is Spring Valley Elementary.
13. All streets along Chapel Road southwest of the Chapel Rd/Meadow Mountain Dr intersection within two miles of Chapel Park Elementary, where Chapel Park Elementary is the home campus.
14. All streets west of Highway 1695 (Hewitt Drive) and south of Ritchie Road within two miles of Park Hill Elementary where Park Hill Elementary is the home campus.
15. All streets south starting with Alamosa Drive to Chama and Romana Circle and West of Highway 1695 within two miles of Castleman Creek Elementary where Castle Creek Elementary is the home campus.
16. All streets west between Fallen Leaf Dr to Ritchie Rd and south of Durango Trail to West Warren St within two miles of Park Hill Elementary where Park Hill Elementary is the home campus.

Hazardous transportation will be from designated bus stops and not door to door service.
