



Visual and Performing Arts Festival:

This Visual and Performing Arts Festival has been an annual event for the past 21 years. This year's festival had over 250 participants from Cooperative districts. We were honored to have Fran Cavenaugh, Arkansas District 30 State Representative, as our emcee. Mrs. Cavenaugh is the past president of The Children's Shelter of Northeast Arkansas, and was named Woman of the year by the Lawrence County Chamber of Commerce. She also serves on the Lawrence Memorial Hospital Foundation Board and the Delta Symphony Orchestra Board.

Teacher Day: NEA Cooperative hosted their annual "Teacher Day" on August 9, 2023, at the Westside School auditorium.

The morning session training covered the required PD Teen Suicide Awareness and anti-bullying.

The afternoon session was "How to be a Baller Teacher" presented by Tyler Tarver. For new teachers and experienced teachers alike! Teachers were given steps to reach and influence today's learners (The Selfie Generation), but with that old-school respect and focus. Practical advice mixed with videos and experience sprinkled with humor(ish) and a dab of The Dab. Utilizing fun/creative elements/apps to engage and focus on being authentic to your personality in the process!

Athletic Coaching Institute:

The Athletic Coaching Institute is a two-day annual collaboration between ASU, Crowley's Ridge Education Cooperative and the Northeast Arkansas Education Cooperative. For over a decade Ron Carrol, director of the Institute, has provided trainings on-site at ASU on a variety of topics.

Teacher Center:

This year we have been able to serve our 14 districts in creative ways. We worked closely with our schools to create classroom materials for countless teachers. We were able to assist our districts with materials for improvement projects in Literacy, Science, Math, Special Education, and behavior. We worked closely with our districts to develop materials to visually show a student's progress as well as encourage growth. We were able to work with our preschool teachers to develop materials that will improve gross and fine motor skills. We created materials used for many school events throughout the year.

We have been fortunate to serve our community as well. We work closely with our local hospital and nursing homes to develop materials used to assist staff and residents. These materials aide staff in workplace safety, daily duties, trainings, and morale. Residents received materials to increase activity levels, cognition, improve daily functioning, and medical/dietary needs. We have created many materials used in community events. Some of these include local festivals, parades, upcoming elections, and community outreach. We have worked closely with local churches to provide materials for Sunday school, VBS, programs, Bible studies, and upcoming events. We have worked with nonprofits to create materials for fundraising. We have created flyers for food pantries and clothing distribution. We work closely with area libraries to create materials for daily and event use. We create materials used in local businesses as well as working with community members on personal projects.

- Staff Qualifications: Each preschool classroom has a classroom teacher that is fully certified, or is working under an SQP (Staff Qualification Plan) in order to acquire certification. Each classroom has a paraprofessional who has completed an Associate's Degree, or a CDA certification, or is working toward certification under an SQP. A floater is also employed at each site. All staff, including floaters and substitutes are required to take an 8-hour New Staff Orientation training, which provides a general overview of the rules and regulations pertaining to the program.
- Licensing: All programs have met Quality Approval Child-Care Standards and have met or exceeded their Better Beginnings ratings. The Better Beginnings ratings range is from 1 to 6. We currently have five sites with a rating of 3, and three sites that have leveled up to a 4.

MAJOR HIGHLIGHTS OF THE YEAR:

1. All sites have major upgrades completed at their sites. Some of the major improvements include large custom playground structures, shades, and trike paths, along with additional

smaller structures such as balance beams, stationary buttons, spin cups, seesaws, dome climbers, ball toss-ups, chalkboard flowers, and more. Each site was able to customize their site to the needs of their students.

- 2. All sites are working to implement the Science of Reading practices at the preschool level using developmentally appropriate practices that development oral language skills and phonological awareness, both precursors to becoming proficient readers.
 - (a) Teachers are wrapping up their second year of fully implementing Launchpad, which is the mode of delivery for literacy instruction at the preschool level.
 - (b) Teachers administered beginning-of-year (BOY) and end-of-year Launchpad assessments (EOY) in order to measure growth in such areas as phonological awareness, upper-case and lower-case letter recognition, etc.
 - (c) Updating staff files, including substitute teachers, and providing notification and support to personnel needing required professional development.
 - 1. Worked with ABC Licensure to ensure that all teachers and paraprofessionals have the training in the 12 required areas.
 - 2. Hosted a workday for substitute teachers to assist them in completing the mandated New Staff Orientation training

3. Implemented the newly-adopted Frog Street Curriculum. Frog Street is a comprehensive curriculum that covers literacy, math, and science through a myriad of engaging, hand-on activities.

4. Supported ongoing professional development opportunities for preschool teachers, paraprofessionals, floaters, and substitutes. Staff and substitutes received onsite training in CPR/First Aid, New Staff Orientation, ethics, updates to the program, etc.

5. Supported staff in working toward higher education levels by providing assistance in applying to the T.E.A.C.H program. This program pays 95% of the cost of tuition and books and provides release time for the participants to work on their coursework.

6. Encouraged participation in the Step Up to WAGE\$ initiative, which provides twice yearly stipends to qualifying staff (criteria based on hours worked and salary) as an incentive to help retain staff by supplementing wages.

The ACT Prep Grant is designed to provide additional support to students in grades 7-12 in preparing for the ACT. Through this grant, all districts in Arkansas had the opportunity to opt-in for additional support for their students in taking the ACT. The grant included a subscription to On To College for high school students and prep sessions for any student taking the ACT. 261 school districts across the state opted-in to OnToCollege. This program can be used at the school level in multiple ways. Schools are able to use this resource as a class during the school day, an afterschool program or a summer bootcamp. Training was provided to each district. Through this grant cooperatives hosted ACT Prep sessions for students to participate in prior to their ACT test. Chad Cargill provided 9 sessions for 688 students across the state. Each student spent three hours in a live session with Chad Cargill working on strategies for taking the ACT as well as content review.

Cantrell and Waller Preparatory (CW Prep) provided 24 sessions across the state to almost 2,000 students. In these sessions, students spent six hours studying content from the ACT. CW Prep also shares strategies with students when taking the test. Students leave the training with a one-year log-in to all the resources that were shared so they can use them to continue studying for the ACT.

The ArPEP facilitator will prepare educators who understand what accomplished beginning teaching looks like in a classroom, and more importantly, demonstrate how effective teachers design lessons, provide instruction, build classroom communities, and utilize assessments to facilitate student learning.

For the school year 2023-2024 ArPEP Year 1 had 11 candidates and ArPEP Year 2 had 9 candidates.

ADE in collaboration with the Arkansas Educational Cooperatives and other partners must support quality computer science educator development and training opportunities for all Arkansas Educators and Administrators.

3. Licensure - Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to licensed and endorsed computer science teachers. ADE will continue and further research and implement, when appropriate, flexible licensure pathways and practices, based on legislation and regulation.

4. Outreach and Promotion - Successful implementation of computer science education in Arkansas requires the active use of a broad range of mediums, digital tools, and human networks to properly communicate about the Arkansas Computer Science Education Initiative and respond to the needs and concerns of Arkansas students, educators, community members, and industry leaders.

5. Program Growth and Student Success - Successful implementation of computer science education in Arkansas requires encouraging broad school implementation, supporting lighthouse schools to expand their programs, increasing statewide teacher capacity, growing student interest, and increasing stakeholder interest and support through the use of innovative programs and outreach initiatives.

GOAL: The Northeast Arkansas Education Cooperative Early Childhood Special Education program will provide speech/language services, developmental therapy, contracted services such as occupational therapy and physical therapy and any necessary referrals to meet the needs of children with disabilities, ages three through five, within our Cooperative districts.

PROGRAM SUMMARY: The Early Childhood Special Education program serves children in 7 Head Start locations, and 20 private daycare centers, as well as all of the ABC classrooms that are located on the 11 school campuses. Early Intervention Day Treatment (EIDT) centers are opening in and around the Jonesboro and Paragould areas. We are serving children in approximately 17 EIDT locations. Since COVID, we are having more parents attend conferences by alternate means such as phone and video. We are happy to accommodate these requests and are continuing to learn better ways to conduct these conferences that are more convenient to parents. The program continues to cooperate with the area AASEA group. This is a collaborative relationship among the Early Childhood coordinators and the LEAs for the schools that serve the preschool and school age special education population in our region.

PROGRAM SUMMARY: The Division of Elementary and Secondary Education (DESE) English Learner (EL) support program provides assistance through the Teacher Center Coordinators for the professional development of teachers and administrators in the implementation of the effective English for Speakers of Other Languages (ESOL) program design and delivery. The program supports assistance, upon request, with school improvement and ESOL program planning for ELs. The program also coordinates ESOL professional development training and convenes regional meetings of ESOL personnel to discuss strategies and share resources used to instruct ELs under the Arkansas Legislation.

<u>Purpose</u>

Since 2004, the escWorks platform has been used across the state to house professional development hours required by Arkansas law to renew and retain teaching licenses and certifications. escWorks is an event management software that can schedule and track professional development offerings online. It then produces reports to quickly and clearly communicate services provided or taken over time. The software is made up of multiple online modules designed to schedule events, manage data, and most importantly, keep track of educators professional development hours. Before escWorks was purchased, there was not a consistent and logistical platform to track educator professional development in Arkansas. **Goal**

By using escWorks, Arkansas school districts and administrators can access professional development history from any educator at any location across the state. This platform allows for school districts to easily verify employment history and trainings when they are interviewing and selecting high-quality educators for open positions.

Whether an educator has taught one year or twenty, they can use the platform to see their history of professional development and courses taken over their career. They can print transcripts and reports to keep in their personnel files or personal folders. Participants also have the ability to print a certificate of completion after a training.

Additionally, after each training session, a professional development evaluation survey is sent to all participants. The surveys are identical in the platform and allow participants to share feedback about trainings that our staff or guest presenters instruct. Our cooperative staff and specialists use the data from these surveys to improve instruction and grow in methodology. We measure the level of implementation of knowledge and skills participants had before and after attending the training. The comment section at the end of the survey is another tool we use to gain personal feedback from the teachers we support. It also allows us to closely inspect our practices and delivery methods.

Each Educational Cooperative assists their local school districts with escWorks in the following ways:

- Hosting trainings for new and veteran teachers on how to use the platform.
- Input trainings, meetings, and other events that participants can select to attend for yearly professional development.
- Check attendance records with district administration to make sure professional development requirements were met.
- Mark attendance in escWorks after a training is completed.
- Answer Help Desk questions that come from users of escWorks.
- Assist current and retired educators with obtaining records and reports.

Each of the fifteen Educational Service Cooperatives and the Arkansas Department of Education split the cost of this service each year. Approximately \$6,242.62 was paid by each entity for site maintenance and support FY23-24. Southeast Service Cooperative handles the renewal and purchase of this program each year. The total amount paid to escWorks to cover Region 4 (Arkansas) was \$99,881.93 FY 23-24.

GOAL:

The goal of the Northeast Arkansas Education Cooperative's Gifted and Talented Program is to assist member districts in coordinating, implementing, evaluating and improving local programs for gifted and talented youth. This goal is pursued through two primary objectives: (1) to develop and implement the Co-op's technical assistance activities in gifted education and to assist member districts to meet the standards for gifted and talented education; and (2) to provide a liaison with the office of Gifted and Talented Education, DESE, parent and professional organizations, and other public and private agencies and conduct public awareness and advocacy programs.

PROGRAM SUMMARY:

During the 2023-24 school year a broad range of services were provided that incorporated the five strands: on-site consultation and technical assistance; curriculum materials and resources; in-service and staff development; K-12 student activities; community involvement, and professional development activities. Specific needs of school district's G/T Coordinators, facilitators and students were addressed through the following activities and/or presentations: Project Fair for students in grades 3-9; a creative writing project called the Story Store for students in grades 3-6; four quiz bowl competitions for students in grades 3-12; Odyssey of the Mind competition for students in grades K-12; Business Expo in grades 5-9; and, three chess tournaments for grades 3-12.

Staff development opportunities included: Whole Group Enrichment; support for EL/GT students, identification of minority students, cross-curricular support, enrichment opportunities and partnerships, and community outreach. The GT Specialist met monthly and communicated weekly with the ADE and other GT Specialists to gather and exchange information on current trends, practices and programs in gifted education. This information was then shared with all district GT Coordinators.

Special roles and responsibilities assumed by the GT specialist include: Active member of Arkansans for Gifted and Talented Education (AGATE), attending the State AGATE Conference; active member of Arkansas Association of Gifted Education Administrators (AAGEA), State

Director for Arkansas Odyssey of the Mind, Board Members for the Arkansas Advanced Initiative for Math and Science (AAIMS).

- Secondary Course Content Training was offered throughout the State for those in our districts that needed training.
- Conducted school Pre-Application Workshop and ADE Zoom Meetings for GT Coordinators

GOAL:

HIPPY's goal is to assist parents in laying a foundation for future school success by providing educational enrichment to their preschool children. HIPPY offers parents with support, training, and materials so they can engage in developmental and effective activities with their children. We believe parents are a child's first teacher and every child should enter kindergarten prepared and ready to learn. HIPPY inspires and promotes interactions that lead to success. We empower parents as their children's first teacher by giving them the tools, skills, and confidence they need to work with their children in the home. Families participating in HIPPY receive all books and learning materials free of charge from their local program.

PROGRAM SUMMARY:

HIPPY is a developmentally appropriate, early literacy curriculum designed to promote children's cognitive, social, emotional and physical development. The curriculum consists of a

set of easy-to-use educational activity packets and storybooks developed for parents of children ages 2-5. Parents engage with the curriculum by role playing the parent-child activities with a home visitor who is from the same community, and often a former HIPPY parent. All home visitors are supervised by a professionally trained program coordinator. Through the delivery of the HIPPY curriculum home visitors empower parents to build strong relationships with their children through activities and engagement that prepare them for school. The HIPPY model has four components:

- Curriculum
- Role Play
- Coordinators & Home Visitors
- Home Visits and Group Meetings

Each of the four features of the HIPPY model was chosen and developed in order to allow participation from parents who might otherwise not get involved with their children's education. Although HIPPY is for any parent who wants educational enrichment for his/her child, the HIPPY model was designed to remove barriers to participation due to lack of education, poverty, social isolation and other issues.

MAJOR HIGHLIGHTS OF THE YEAR:

- The NEA Education Cooperative HIPPY program served 38 families this year with a total of 38 children. Some families include: single or divorced parents who are trying to raise children on their own, foster parents, and grandparents who are starting parenting again with grandchildren.
- Monthly parent meetings have included Fall field trips to Pumpkin Hollow and Jackson Farms. Healthy meal ideas for families with hands-on cooking; a Winter celebration; a visit from Cat-In-The-Hat during Dr. Seuss month that included book rewards for participation in a month-long reading contest, visits from kindergarten teachers from various schools to inform parents of the school's expectations as well as what parents can do to make their child's educational experience optimal, visited and toured local fire departments to learn about Fire Safety and what children can expect when they see a firefighter in full uniform, and ended with a End of Year Celebration at Ultimate Air Trampoline park to celebrate the 13 HIPPY Program graduates.
- Advisory Team was made up of 18 individuals from each local community of the 5 counties we serve. We had 1 meeting this year held at the NEA Education Coop. The luncheons included guest speaker, Amanda Kirby, Behavioral Specialist. She was here to discuss behavior basics that help us understand why behavior occurs and also continues.

RISE Academy (K-2) RISE K-2 is a professional development for teachers based on the results of several thousand studies regarding how children learn to read. Through this "science of reading" approach, the five fundamental components of literacy instruction are addressed during six days of face-to-face training delivered by certified RISE trainers. These five components include phonemic awareness, phonics, reading fluency, vocabulary, and reading comprehension.

The focus for each of the six days includes:

- Day 1 (Summer)-The Science of Reading
- Day 2 (Summer)-Oral Language and Phonemic Awareness
- Day 3 (Summer)-Phonics
- Day 4 (Summer)-Fluency
- Day 5 (Summer)-Oral Language, Vocabulary, and Morphology

Goal: To provide the support, assistance, training and encouragement to the Novice Teachers from among the 13 participating NEAEC member school districts in order that each NT can become an effective, knowledgeable teacher and remain in the teaching profession.

PROGRAM SUMMARY:

The Mentor Program Specialist mentored **53 Year 1, 74 Year 2 and 69 Year 3 Novice Teachers** for a total of **196** in the school year 2023-2024.

Multiple sessions were conducted with Novice Teachers, Year 1, Year 2, and Year 3 during the summer months and throughout the school year. Connections were made with the new teachers when and as they were hired. During those informal meetings, the Mentor Program Specialist regularly communicated with all Novices to provide teachers with updates and gathered data to determine the individual assistance needed. Year 1 NT's were provided elemental training on EscWorks, Arkansas Ideas, and other websites that would be used during their upcoming year in order to be "Day One Ready" for the first day of school. Year 2 and 3 Novice Teachers met in several group meetings at points of availability. The Mentor Program Specialist worked with district Points of Contact (POC's) to maintain accurate records and share district cited needs fielding questions that might arise during the school year. POC's were a valuable resource to facilitate communication between the Coop and districts. 100% of the Novice Teachers were assigned local mentors. Program plans for the year were outlined in an MOU and signed by district administrators.

There were **5 Novice Teacher Year 1 Days** conducted live in summer sessions and virtual sessions during the school year:

Then in January, 2023, twenty-seven principals joined virtually to discuss Essential Standards Impact, Arkansas Grant Opportunities, Teacher Residency Model, AACA Scholarships, PLC Initiative, Computer Science Updates and other relevant updates.

Twenty – nine principals met virtually April 17, 2023 to gather information about HQIM, discuss PD Needs Assessment Results, to hear information about the new assessment beginning in the 2023-2024 school year, to hear about the new middle school CTE courses and other information relative to their roles as school leaders.

GOAL: The goal of the Science Specialist is to assist the state with job-embedded professional learning; to provide targeted technical assistance to schools identified as in need of support; and to support the implementation of content standards, assessment practices, and curriculum work. The Science Specialist will provide ongoing support for adult learning in best practices in science education. This support includes raising awareness of the AR K–12 Science Standards and providing implementation tools and techniques to achieve success.

PROGRAM SUMMARY: The office of the Science Specialist supports teachers, administrators, and schools by providing quality professional learning opportunities and ongoing site-based support in instruction, leadership, and best practices. Instructional support such as statewide science professional development (i.e., standards introduction, phenomena routines, ATLAS, assessment, and unit development) was provided to support implementation of the Arkansas K–12 Science Standards, model and provide resources for phenomena-based instruction, and incorporate ELA and Math standards. Support for Science Novice teachers was provided through on-site visits and observations. Science content was addressed through various texts such as Disciplinary Core Ideas: Reshaping Teaching and Learning, which informs K–12 science content while addressing Literacy Standards, Science Standards, science inquiry, and the storyline model of instruction. On-site visits to support the creation and delivery of assessment tasks, engineering, classroom management, and lesson/unit planning occurred throughout the year. Professional learning opportunities for science focused on awareness of, transitioning to, implementation of, or sustaining work with the Arkansas K–12 Science Standards, STEM, and Solution Tree training sessions. The Innovative Partnership with Williams Baptist University was continued that brought pre-service teachers to the coop. These pre-service teachers were directly instructed in the current Science Professional Learning Continuum PD sessions. This partnership increased awareness of the AR K–12 Science Standards among the pre-service teachers, understanding of the importance of phenomena first science, and gave practical experience through student placements and lesson development. Direct coaching support was provided throughout the year to teachers at Lawrence Co., Maynard, Pocahontas, Rector, and

Sloan-Hendrix. Coaching support focused on five impact areas: Structures for learning, science aligned content, science teacher instructional practices, student practice, and assessment and differentiation. The Science Specialist worked with coaches to set goals specific to the impact areas and provided resources, tools, and lesson modeling to support those goals. The Science Specialist partnered with other Specialists and agencies to provide eclipse glasses for all member districts and PD for data collection and analysis for interested teachers. The Science Specialist, in partnership with Astronomers Without Borders, will serve as an eclipse glasses collection site and provide community service hours for member district high school students to help meet the graduation requirement.

Communities of Practice (CoP)

Description:

Building Communities of Practice (CoP) is focused around Identifying Learning Loss and Accelerating Learning using High-Quality Instructional Materials (HQIM). DESE, in partnership with a national partner, will bring together groups of Arkansas system leaders (district and school teams). The Community of Practice will explore the leadership practices necessary to implement math and/or literacy instruction and learning supports that meet the moment, while staying focused on long-term recovery and acceleration goals.

The CoP includes a series of sessions that includes research and evidence-based strategies to address and plan for the acceleration of learning using HQIM.

Grantee will select vendors from those approved by Rivet Education to contract with for professional services to engage in content coaching, with emphasis on HQIM.

Arkansas Professional Educator Pathway (ArPEP) Number Trained: ***participants in Cohort 1

Description:

The Arkansas Professional Educator Pathway (ArPEP) is an affordable two-year, work-based training, alternative education route to obtaining an Arkansas standard teaching license for college graduates or career changers holding at least a bachelor's degree.ArPEP's goal is to prepare learner-ready teachers to meet the growing demand of the teacher pipeline in Arkansas. The primary objective of ArPEP is to train future educators on how to build classroom communities, design effective lesson plans, implement evidence-based instructional strategies, and use assessments to facilitate student learning.

The ArPEP facilitator will prepare educators who understand what accomplished beginning teaching looks like in a classroom, and more importantly, demonstrate how effective teachers design lessons, provide instruction, build classroom communities, and utilize assessments to facilitate student learning.

PLC Support 2024

Professional Learning Communities: Boardroom to Classroom - In support of the DESE's PLC Initiative, Co-ops have been participating in the Boardroom to Classroom trainings monthly with Janel Keating from Solution Tree. As part of this process, Janel Keating guided educators in developing successful districtwide professional learning communities to ensure high levels of learning for every student. High-performing districts develop when collaborative teams at every level align their concepts, practices, and vocabulary. Aligning this work is a top-down, bottomup cyclical process, starting with the district level and ending with collaborative teacher teams. This session provided district and school leaders with the tools and strategies needed to create a districtwide culture of continuous improvement. Co-ops are an integral part of this work and have been supporting districts involved in these sessions through Specialist support, and working with administrators who are implementing PLC processes.

*The Guiding Coalition consists of the NEA Content Specialists, the Teacher Center Coordinator and the Director of the NEA Education Cooperative. Meetings were held the 2nd Thursday of each month. The coalition met to build a collaborative culture by sharing knowledge of our districts with a focus resulting in an alignment of our smart goals to fit our desired outcomes.

Act 1082 Support (Revise as needed)

While literacy coaching is a part of the ESC literacy specialists' work, it is just one of many workstreams for these individuals. As a result, districts receive varying intensity of support from literacy specialists, based on their ADE Progressive Levels of Support classification, and the fact that not every school that needs support receives it. Arkansas has 5 levels of support (General, Collaborative, Coordinated, Directed, and Intensive) determined, in part, by a district's student reading outcomes on the state summative assessment. Arkansas literacy specialists support only Levels 3-5:

• Level 5 - Intensive Support: ADE literacy specialists conduct weekly site-visits to provide coaching and feedback in schools. Arkansas currently has five districts at this level. The percent of students that met the ACT Aspire readiness benchmark in these districts is just 13.86%, compared to a statewide average of 35%. Of the Level 5 districts, 3 have adopted approved HQIM in K-3, 1 has adopted approved HQIM in K-2 but not grade three, and one district has not adopted HQIM.

• Level 4 - Directed Support: ESC literacy specialists provide support to districts in their region including coaching teachers, model lessons, walkthroughs with principals and professional development around the Science of Reading. Arkansas has 37 districts that receive this support. The percent of students that met the ACT Aspire readiness benchmark of these districts is 21.95%. Of the districts, all but one have adopted approved HQIM in K-3.

• Level 3 - Coordinated Support: ESC literacy specialists provide support to districts in their region including coaching teachers, model lessons, walkthroughs with principals and professional development around the Science of Reading. Arkansas has 67 districts that receive this support. The percent of students that met the ACT Aspire readiness benchmark of these districts is 27.91%. Of the Level 3 districts, 29 have adopted approved HQIM in K-2, 7 have partially adopted HQIM in K-3, and 1 has not adopted HQIM in K-3. Act 1082 is designed to provide specific levels of support to public school districts based on reading scores.

The goals of this support include helping schools deploy more powerful strategies, use resources more productively, and analyze the curriculum that is used. To that end, both Level 3 and Level 4 schools meet periodically with the Public School Program Advisor from the DESE and the co-op team either virtually or in-person. Level 3 schools are required to meet once every nine weeks and Level 4 schools meet monthly. During these meetings a spreadsheet is reviewed that includes the topics: Literacy Curriculum, Assessments, Science of Reading,

Dyslexia, and Writing Revolution. This spreadsheet is a living document that all stakeholders can update as actions are taken in support of any of the given areas.

ESC Literacy specialists also provide regular support throughout the year to these schools. This support can be in the form of model teaching, professional development for teachers and/or paraprofessionals, classroom walkthroughs with principal, or anything that is identified by the school or in the coordinated meetings. The professional development opportunities are designed to provide personalized support to ensure that all teachers acquire the instructional expertise needed to educate all students and improve reading skills.
