This letter transmits an update from Plante Moran Cresa (PMC) as it relates to the assignment to assist and advise Livonia Public Schools (LPS) in its selection of Prime Contractors for the Projects listed above. This update represents the mutual efforts of PMC, George W. Auch Co., Stantec, LPS administration and staff (the Bond Team) to present a framework in order to identify, evaluate and recommend Prime Contractor firms for this Project.

On January 8, 2016 Construction Documents were formally issued and made available. An advertisement for bids was published in a local newspaper and also posted to the required State of Michigan websites.

On February 9, 2016 100 bid proposals were received, and over the next several days were reviewed to determine the budget implications. Interviews were held over the next week and were attended by various members of the Bond Team.

Upon completion of the interviews, and after subsequent clarifications and discussions, the Bond Team is recommending the firms listed in George W. Auch Co.'s Award Recommendation Letter dated February 19, 2016 for contract award. Including hard construction, CM fees and costs, and construction contingency dollars, the total Project award recommendation equals 18,452,254.

For the Prime Contractors, the costs for this work will be detailed in AIA Contract A132 – 2009 Standard Form of Agreement between Owner and Contractor. The CM costs and fees will be detailed in Amendment #04 to AIA – C132 – 2009 Standard Form of Agreement between Owner and Construction Manager, both pending final review and approval by district legal counsel.

The Project Team is available at the Board's convenience to answer any questions regarding bidding, the proposals, interview process, or the recommendations of the Bond Team. Please direct all questions through me via email.

We have completed the review of the bids received on February 9th, 2016 for the Performing Arts Addition and Renovation project at Stevenson High School. The George W. Auch Company is pleased to present the recommendations for award of contracts per the attached schedule. We recommend awarding to the low responsive bidders with complete bid scope.

After post-bid evaluation, we have determined that Rayhaven Group made a clerical error and was not intending to bid the Proposal A – Selective Structural Demolition proposal and used the incorrect proposal forms. Rayhaven Group has requested that their bid be withdrawn from consideration. Therefore, we are recommending Blue Star Inc. to be awarded the bid category of Proposal A – Selective Structural Demolition as the low responsive bidder.

After post-bid evaluation, we have determined that Reliable Fence made a clerical error and does not have a complete scope of work for Proposal FF – Chain Link Fence and has requested that their bid be withdrawn from consideration. Therefore, we are recommending American Fence & Supply to be awarded the bid category of Proposal FF – Chain Link Fence as the low responsive bidder.
