A. Policy 6172.3 - Educational Instruction under Parental Direction (Home Schooling) The subcommittee followed up on last meeting's discussion regarding partially enrolled students who are home schooled. Attorney Andy Bellach was present by phone to provide guidance on the matter. Subcommittee members discussed whether or not home schooled students could attend 1-2 classes per day, under the same protocols as visitors, in order to ensure insurance coverage. Atty. Bellach was unable to confirm whether or not students would be covered, after speaking with CIRMA. Other concerns were raised by Ms. Bellach including discrimination under protections of the 14th Amendment, IDEA statutes, and district liability for students including bullying. Samantha stated that she did not think that the Board was ready to repeal the policy entirely, and the subcommittee agreed on substantial revisions to the policy.
