6. REPORTS

A. Policy Review - First Reading #524 Internet Acceptable Use and Safety, Josh Swanson, Moreen Martell

This includes MSBA recommended updates. Provisions clarify posting of employee and student information online. Added new requirements generated from the Federal Broadband Data Services Improvement Act to educate students on social networking websites and in chat rooms and cyber bullying awareness and response. The newly developed BHM eCommunication guidelines are now referenced and protocols are clarified.

Discussion – who teaches this at the building level. This is being determined and

will be laid out in scope and sequence.

B. NCLB Waiver, Scott Thielman

Minnesota received a waiver from the No Child Left Behind law. The proposed accountability system includes the same current academic standards, assessments, public reporting, calculation of AYP and disaggregating data requirements. New, due to the waiver, are AYP targets, elimination of sanctions for not making AYP, elimination of financial set-asides for AYP, flexibility with federal funds and school improvement planning. 2014 requirement of 100% passing is still in place. Schools will be given an annual Multiple Measurements Rating (MMR) consisting of proficiency, student growth, achievement gap closure and graduation rate. MMR is used to assign Title I schools to three categories – Reward Schools (top 15%), Priority Schools (bottom 5%), Focus Schools (middle 10% with extreme achievement gaps).

Discussion – how do we compare regarding graduation rates. We are traditionally at a 97% graduation rate. Pretty similar around the area. MCA scores are compared more often. Any movement for states to use the same cell size calculations – yes.

SL – Foundation – Pork Chop dinner on April 12, Staff Showcase earned about \$3500. Looking at new fundraising ideas, also WTC

PP – Community Book Read will take place in late April, NWSISD – task force has made its recommendations but no legislative action will take place until 2012-13. Our contribution to NWSISD will be less next year.
