The demolition project of Nankin Mills and Washington School was posted as a completive bid on March 6, 2014. Specifications were made available on March 10, 2014 and the bids were opened on Thursday March 27, 2014. There were ten contractors that submitted bids for this project.

After reviewing their bid submittals and interviewing the contractors that submitted the three lowest bids, I am recommending that Ahern Contracting, Inc. of Chesterfield, MI be awarded the contract to demolish Nankin Mills School. I am recommending that International Construction, Inc. of Shelby Township, MI be awarded the contract to demolish Washington School.

The three lowest bidders for Nankin Mills demolition project were Ahern (\$186,432.00) International (\$189,900) and Universal Consolidated Enterprises Inc. (\$204,029). The three lowest bidders for Washington demolition project were International (\$179,900), Ahern (187,000) and Universal Consolidated Enterprises (\$228,650).
