**A. ACTION ITEMS**

**1. Wayne County Enhancement Millage**

Pursuant to state law, the revenue raised by the proposed enhancement millage will be collected by the Wayne County Regional Educational Service Agency and distributed to local public school districts within the boundaries of the Wayne County Regional Educational Service Agency based on pupil membership count. Funds would be distributed on an equal, per student basis to each individual school district in Wayne County.

**RECOMMENDED ACTION:** That the Crestwood Board of Education approve the Wayne County Enhancement Millage and that the Secretary of the Board submits a copy of this resolution to the Secretary of the Wayne RESA Board of Education. See Attachment 7.A.1.

**2. Field Trip Request – Riverside Middle School**

Riverside Middle School has requested day trips for 5<sup>th</sup> grade students to attend Camp Ohiyesa in Milford, Michigan. The following are the requested days for three groups of students:

**3. Renewal of Frontline Education Agreement – Absence and Substitute Management**
