Item I. Call to Order- Establishment of Quorum

The meeting was called to order at 5:55 p.m. A quorum was established.

Item II. Board Consideration and Possible Action Upon the Recommendation of the Superintendent of Schools Regarding the Expulsion of Student A from Stafford High School Pursuant to CGS 10-233d (Executive Session Anticipated)

Mrs. Locke made a motion, seconded by Ms. Bachiochi, that the Board enter executive session to discuss material that would result in the disclosure of public records or the information contained therein as described in Connecticut General Statutes Sections 1-200(6)(E), subsection (b) of Section 1-210, specifically, personnel, student or medical and similar files the disclosure of which would constitute an invasion of privacy, and / or names and addresses of students enrolled in public school. Only those invited by the Board may be present in the executive session. Ms. Bachiochi, Mr. Delano, Mrs. Locke and Mrs. Walsh voted for the motion, which carried. The Board entered executive session at 5:56 p.m.

The Board requested that all invited individuals leave the meeting room at 6:30 p.m., with the exception of Attorney Dorsey, so that they could deliberate. All invited individuals were allowed to return to the meeting room at 6:36 p.m.

The Board requested that all invited individuals leave the meeting room at 6:55 p.m., with the exception of Attorney Dorsey, so that they could deliberate. All invited individuals were allowed to return to the meeting room at 7:40 p.m.

Mrs. Locke made a motion, seconded by Mrs. Walsh, that, pursuant to Connecticut General Statutes Section 10-233d, the Stafford Board of Education shall expel the Student (Student A) discussed in executive session from attendance at Stafford High School for the period from January 22, 2019, through and including January 21, 2020, for the reasons presented by the administration in this hearing. During any period of expulsion, Student A will not be allowed on school property or at school sponsored events without the express written permission of the Superintendent.

Further, the Board directs the administration to offer an alternative educational opportunity to Student A for the period of this expulsion, pursuant to Connecticut General Statutes Section 10-233d(d) and regulations for the State Department of Education, of a minimum of 10 hours per week of tutoring and, in addition, school-based counseling regarding positive decision making.

The Superintendent is also authorized to allow early readmission at the start of the 2019-20 school year, if Student A meets the following conditions:

- 1. Zero unexcused absences from tutoring or counseling in a form and frequency to be approved in advance by the Superintendent;
- 2. Appropriate grade level performance consistent with Student A's past history; and
- 3. No further violations of school rules or the law.

Upon any early readmission, Student A will be on probation for the remainder of the expulsion period, but will be allowed to participate in school activities. During this period of probation, Student A must meet all requirements of early readmission. If these conditions are not met during the probationary period, the Superintendent is authorized to reinstate the remaining term of Student A's expulsion without the necessity of further action by the Board.

The Board further directs the administration, pursuant to Connecticut General Statutes Section 10-233d(f), to record this expulsion on Student A's cumulative educational record, to be expunged from such record if Student A graduates from high school, or in accordance with further actions of the Board or then existing Board policy.

Finally, the Board authorizes Ms. Sonya Shegogue and Attorney Fred Dorsey to communicate in writing to Student A and/or his/her parents, as appropriate, the Board's decision and the reasons therefor, consistent with the Board's executive session discussion.
