## **BORDER DISTRICT AGREEMENT**

THIS AGREEMENT, made and entered into this 20th day of September, 2018, by and between the duly elected, qualified, and acting Boards of Trustees of School District No. 150, County of Caribou, State of Idaho, Party of the First Part, and School District No. 2, County of Lincoln, State of Wyoming, Party of the Second part, each Board acting for and on behalf of the school district which it represents, pursuant to resolution duly passed by the board of Trustees of each of the contracting districts.

## WITNESSETH:

- 1. That the above school districts do hereby enter into an agreement as provided by Section 33-1403, Idaho Code.
- The Party of the first Part hereby agrees to send approximately;
  28 full time pupils residing within its borders, to the school or schools maintained by the Party of the Second Part.
- 3. Transportation of said pupils mentioned in the preceding paragraph is to be provided by the District No. 2, Party of the Second Part.
- 4. The Party of the Second Part hereby agrees to admit all pupils covered by this agreement under Number 2 above, and coming from District No. 150, Party of the First Part, to instruction in its schools and to offer them the usual privileges and accommodations provided for its own pupils, including the furnishing of textbooks and supplies if this is the practice in the educating district.

The place where school shall be held shall be Lincoln County School District No. 2, and the length of the term shall be nine (9) months which shall include a minimum of 166 days of school.

- 5. In return for such services hereinafter set forth in Wyoming State Statue 21-4-504, said Party of the First part agrees to pay to the Treasurer of the Party of the Second Part an amount of money based on the average daily attendance of the students from District 150;
  - per capita cost of \$14,915.87
  - payment(s) in the amount of \$417,644.24
  - on the following dates

 February 15
 June 1
 \$104,411.06
 \$104,411.06
 \$208.822.12

Any remaining balance of the aforementioned sum shall be paid on or before June 30, 2019.

- 6. This agreement is to be in force and effect for the fiscal school year 2018-2019.
- 7. The Party to the Second Part agrees to furnish to the Party of the first Part all necessary statistical, financial and other supporting data required by the Idaho State Board of Education for the purpose of determining the cost of educating said children and to enable district, county and state offices to verify and support the disbursement of funds to the district involved.

WHEREFORE, the said parties to this agreement, acting through their respective Boards of Trustees, have hereunto set their hand and seal this 20th day of September 2018.
