


HIDDEN VALLEY HIGH SCHOOL  
MUSTANG SOFTBALL SCOREBOARD ADVERTISING AGREEMENT

1. PARTIES. This Advertising Agreement (hereinafter "Agreement") is entered into on September 12, 2022, between Evergreen Federal Bank, (hereinafter "Evergreen"), Three Rivers School District (hereinafter "District"), and Hidden Valley High School (hereinafter "HVHS") each located in Grants Pass, Oregon. Evergreen, District, and HVHS, are each individually referred to hereinafter as a "Party," and collectively as the "Parties."
2. PURPOSE. Evergreen has agreed to sponsor the HVHS Softball Scoreboard in exchange for the exclusive rights to place the Evergreen Logo on the Scoreboard, for the life of the Scoreboard. District has agreed to grant Evergreen the exclusive advertising privileges related to the Scoreboard as set forth in this Agreement.
3. PAYMENT. Evergreen agrees to provide the requested \$17,118.00 payable to HVHS for the Logo application on the Scoreboard.
4. GRANT OF ADVERTISING RIGHTS. In exchange for the Payment delivered to HVHS, District and HVHS grant Evergreen exclusive right to the place the Evergreen Logo, as seen in Exhibit A, on the Scoreboard for the life of the Scoreboard. District and HVHS agree that Evergreen will obtain bank exclusivity to advertising on the Scoreboard and that HVHS will not permit any other financial institution, bank, or credit union to obtain advertising on or within complex of the Scoreboard.
5. INSTALLATION AND MAINTENANCE. District and HVHS shall assume all costs and risk of loss related to the installation and maintenance of the Scoreboard. The Parties agree, in the event of any non-conformities or manufacturing defects in the Scoreboard that they shall cooperate to pursue a remedy for said defects, from the manufacturer or otherwise, to the satisfaction of the affected Party.
6. ENTIRE AGREEMENT. This Agreement is the Parties' entire agreement with respect to its subject matter and supersedes all other agreements, written or oral relating to that subject matter.
7. MODIFICATIONS. This Agreement shall not be amended, modified, waived or adjusted except in a writing signed by parties.
