FREEDOM OF INFORMATION REQUESTS**

**REPORT TO THE EXECUTIVE ADVISORY BOARD  
March 6, 2013**

Mid Valley has responded to three (3) Freedom of Information requests.

- 1) On February 22, 2013, ***Invo Healthcare Associates, Inc.*** requested the following information:
  - a. A list of all bidding vendors and rates per hour per discipline
  - b. Proposals submitted by all awarded vendors

***RESPONSE: Denied.*** The information being requested is exempt from disclosure under Section 7(h) of the Act (5 ILCS 140/7(h)). Proposals and bids for any contract, grant or agreement, including information which, if it were disclosed, would frustrate procurement or give an advantage to any person proposing to enter into a contractor agreement with the body, until an award or final selection is made, is exempt from disclosure. Information prepared by the public body in preparation of a bid solicitation shall be exempt until an award of final selection is made.

  - d. A complete copy of all Mid Valley Administrator contracts with any/all supporting appendices and any/all supporting documents pertaining to the contracts for the 12-13 and 13-14 school years.

- e. Copy of contracts or any/all written agreements between Mid Valley and NIA currently existing or having existed within the past 3 years.
- f. Copy of any/all currently contracted OT/PT's current Illinois Therapy License
- g. List of all Mid Valley OT/PTs along with the step they are currently on on the pay scale
- h. List of all supplies including vendors and dollar amounts for items purchased for the OT/PT department for the 11-12 and 12-13 school years.
