REPORTING & TRANSPARENCY

Facility Usage Reports:

- Annually report detailed information on the square footage of each facility, acreage of land, total student capacity, and enrollment data for each campus and grade level to TEA.

School Board Trustee Information:

- Annually submit identifying and leadership information about board members to the TEA, including the designated chair.

Parental Notifications:

- Develop a clear communication protocol to notify parents of a criminal offense committed against their child within 1 school day of district staff awareness
- Implement TEA's process for districts to notify parents of changes in their child's mental or physical health status while encouraging student parent communication

Compliance Certification:

- Superintendents must annually certify that their districts are following specific laws related to DEI and parental rights, with documentation published on the TEA's website.
