

**RESOLUTION OF THE BOARD OF EDUCATION OF ILLINI  
CENTRAL SCHOOL DISTRICT NO. 189, MASON AND LOGAN  
COUNTIES, ILLINOIS, CONCERNING THE AMENDED  
PETITION FOR DETACHMENT OF MARK AND ASHLEE  
VANETTEN, JOHN ERMELING, AND JOHNNY CLOSE AND  
ANNEXATION TO HAVANA COMMUNITY SCHOOL  
DISTRICT NO. 126**

WHEREAS, the Board of Education of Illini Central Community Unit School District No 189, Mason and Logan Counties, Illinois (“Illini Central”), has received notice that certain residents and taxpayers of Illini Central filed an Amended Petition with the Regional Board of School Trustees of Mason, Tazewell, and Woodford Counties (“Regional Board”) pursuant to Section 7-1 of the Illinois School Code (the “Amended Petition”) sought to detach property described in Exhibit A from Illini Central and to annex the same to Havana Community School District No 126, Mason County, Illinois (“Havana”); and

WHEREAS, the Board of Education of Illini Central has decided to take no formal position in support of or in opposition of Petitioner’s original Petition, and instead informally negotiated with Petitioners to detach a smaller section of Petitioners’ Property, legally described in the Amended Petition, to minimize loss to Illini Central in agreement that it would not object to the detachment; and

WHEREAS, in the event the Regional Board determines that the Petitioners have complied with all requirements of Section 7-1 of the School Code and that the approval of the Amended Petition is warranted, the Board of Education of Illini Central has determined that the rights of the current homeowners and taxpayers of the District to continue their children’s present enrollment in Illini Central schools will not be impaired; and

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Education of Illini Central Community Unit School District No 189, Mason and Logan Counties, Illinois, as follows:

Section 1. That the Board of Education hereby finds that all of the recitals contained in the preambles to this Resolution are full, true, and correct and does hereby incorporate them into this Resolution by reference.

Section 2. That the Board of Education hereby directs that the Superintendent of Schools deliver a copy of this Resolution to the Mason, Tazewell, and Woodford County Regional Board of School Trustees (the “Regional Board”) and requests that this Resolution become a part of the record of proceedings on the Petition.

Section 3. That all other resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed, and this Resolution shall be in full force and effect immediately and forthwith upon its passage.
