#### **FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING**

This First Amendment to the Memorandum of Understanding (the "First Amendment") is entered into between Texas A&M AgriLife Extension Service ("AgriLife"), a member of the Texas A&M University System and an agency of the State of Texas, and the South San Antonio ISD Early Childhood/Head Start ("Collaborator").

WHEREAS, AgriLife and Collaborator entered into a Memorandum of Understanding effective on or about July 17, 2024 regarding scheduling presentations of AgriLife programs, presentation, and/or events at Collaborator's properties (the "Agreement"); and

WHEREAS, AgriLife and Collaborator now desire to amend the Agreement and revise the duration of the Agreement as outlined below.

NOW THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, accepted and agreed to, AgriLife and Collaborator, intending to be legally bound, agree to and hereby amend the Agreement as follows:

Section entitled "Duration" is hereby deleted and replaced with the following:

"Duration:

This MOU becomes effective on the date of the last signature of the Parties as reflected below and shall remain in effect for two (2) years from such date unless earlier terminated as provided herein. The Parties may agree, in writing, to extend the term of this MOU. In addition, this MOU may be modified or amended if both Parties agree in writing. Either Party may terminate this MOU at any time, without cause, by providing 30 days prior written notice to the other Party. This MOU may also be terminated at any time by mutual agreement of the Parties."

Except as specifically modified and amended herein, all of the terms, provisions, requirements and specifications contained in the Agreement and any prior amendments remain in full force and effect. If any terms of this First Amendment conflict with the terms of the Agreement or any prior amendment(s), the terms of this First Amendment will take precedence in all cases. Except as otherwise expressly provided herein, the parties do not intend to, and the execution of this First Amendment shall not in any manner impair the Agreement, the purpose of this First Amendment being simply to amend and ratify the Agreement, as hereby amended and ratified, and to confirm and carry forward the Agreement, as hereby amended, in full force and effect.

This First Amendment may be executed in multiple counterparts and electronic and facsimile signatures shall be treated as originals.
