Re: Recommendation to Award RFQ #110-23 for Construction Related Professional Services

The district determined a need to solicit bids to prequalify construction related professional services to include Architectural, MEP Engineering, Civil Engineering, Structural Engineering, Geotechnical, Materials Testing, Kitchen Design, Roofing, Technology, Security, Landscaping, Asbestos, Facility Planning, Programming, Design, Construction Administration, and Project Management services. As a result, the district issued a request for qualifications (RFQ) #110-23 on April 18th, 2023, for the purpose of retaining a pool of construction related professional service suppliers.

The contract, if awarded, shall be for the duration of the 2023 bond program.

Twenty-three (23) suppliers responded to the solicitation; after evaluations, it is recommended all twenty-three (23) suppliers are retained. A list of the proposed suppliers is attached. If awarded, suppliers will be contracted on an as needed bases.

FISCAL IMPACT:

Project scope includes a 32,000 sq. ft. fine arts rehearsal building and 10,000 sq. ft. tennis center locker rooms to be located on the existing Coppell High School site; renovation and additions to three elementary footprint campuses; 10,000 sq. ft. addition to Coppell Middle School North fine arts; and other projects listed in the following table. Additional projects may be added to this award at a later date.
