WHEREAS, the Board of Education of OAK PARK ELEMENTARY SCHOOL DISTRICT NO. 97, COOK COUNTY, ILLINOIS ("BOARD" or "DISTRICT") conducted a hearing in closed session on December 16, 2014, in the matter of the discipline of Student 20141612 ("STUDENT"), pursuant to Section 10-22.6 of the *School Code*; and

WHEREAS, on the basis of all testimony and evidence presented at said hearing, the BOARD has determined that STUDENT 20141612 is guilty of gross misconduct and/or disobedience; and

WHEREAS, the BOARD has considered: (1) the egregiousness of the student's conduct; (2) the history or record of the student's past conduct; (3) the likelihood that the conduct will affect the delivery of educational services to other students; (4) the severity of the punishment; and (5) the interests of the student;

WHEREAS, the BOARD has determined that the 10-day out of school suspension of STUDENT 20141612 should be upheld; and

Failure to comply with the conditions in the Student Behavior contract shall result in STUDENT 20141612 immediate expulsion and will go into effect without any further action by the BOARD.

Section 3: That the Superintendent or his designee shall send written notice to the parents of STUDENT informing them of the BOARD'S decision.

Section 4: That this Resolution shall be in full force and effective immediately upon its adoption.
