SOFTBALL FIELD

- Install SWPP provisions as needed for our work
- Perform mass grading for the area encompassing the field
- o Install an HDPE french drain along the backstop
- o Install a new 40' tall backstop netting system with 3' tall panel wall
- o Install 6' tall black vinyl coated chain link fence around the perimeter of the softball field
- o Install 1 pair of 8' wide x 24' long, 4 pole open air pre-manufactured dugouts with chain link fencing around all sides
- o Install 1 pair of 20' tall foul poles with a wing
- o Install geotextile fabric over the subgrade and in the collection trench
- o Install standard skinned infield with softball engineered soils
- Laser grade outfield to consistent slopes using laser guided machinery.
- o Install a 4" thick fiber reinforced concrete over 4" aggregate base for spectator area and dugouts
- Furnish and install 2 sets of 75 seat non-elevated aluminum bleachers
- o Install RFT water saver tall fescue sod in the outfield
- o Install a 3" thick, 12' wide red warning track in the outfield
- Build 1 single bullpen lane on each side of the field (2 bullpens total)
- Backfill, seed, and straw all areas disturbed by B&J during construction


