Datta moved, pursuant to the Illinois School Code, 105 ILCS 5/10-20.12a and 10-20.12b, that the Board of Education charge the parent who enrolled the students tuition for each of the students' attendance in the District school during the 2018-2019 school year at the annual per capita tuition charge of \$13,978.22 per student, prorated for each of the students' 96 days of attendance, from the first day of the 2018-2019 school year through today's date, and charge the family the daily tuition rate for each additional day the students attend District 97 schools during any related appeal.
