The 2013-15 state budget expanded private school vouchers statewide, capping enrollment at 1,000 students, and created regional independent charters in the Milwaukee-Racine area. The governor and key legislative leaders want to lift the voucher enrollment cap. We'll explore the implications of voucher expansion for public schools as well as new evidence that suggests students in public schools governed by school boards outperform students in these alternatives.
