The Board of Education Finance Committee met at 6:30 p.m. on Tuesday, August 8, 2016, at the Coultrap Educational Services Center, 227 North Fourth Street, Geneva, Illinois.

1. CALL TO ORDER (Bylaws 0163 & 0164)

The meeting was called to order at 6:30 p.m. by Bill Wilson.

3.1 July 25, 2016

4. DISCUSSION/CONSIDERATION (Bylaw 0155)

4.1 2015-2016 Year End Review

The Assistant Superintendent of Business Services presented to the committee an end of year review. Revenue received is at 106.6%, and local funds ended at 106.7%. The transfer of Abatement funds contributes to the overage. State funding ended at 104.1% with only three quarterly payments received but funds in arrears was also received, contributing to the overage. Federal funding ended at 112.4%. Some areas came in higher than expected. Expenditures finished at 101.5% of budgeted amounts.

4.2 2016-2017 Discussion/Decision Schedule

The committee reviewed the discussion topics for 2016-2017. Topics are carried over from the previous year and adjusted as needed. There are a couple of slots open for potential discussion topics.

Comments, questions, concerns: We may want to add a discussion on underwriting? (We are scheduling an S&P rating call for September 6 or 7, which is prior to the September 12th meeting. We need to get the documents out from our last meeting to the whole Board. Maybe we could have a short discussion at the next Board meeting to go over the options presented by Ms. Hennessey. Didn't know if the committee would want another banking update from MB Financial? (Possibly.) If we need to we can add the refunding to September. The earliest we can move on refunding is in October.
