

Aubrey ISD And AAYSA Facility Use Agreement

Pursuant to local facilities use policy approved by the Aubrey ISD Board of Education, the following agreement between the Aubrey Area Youth Sports Association, hereafter referred to as the AAYSA, and the Aubrey ISD was reached regarding the use of Aubrey ISD facilities.

Aubrey ISD and AAYSA will appoint one person from each organization to represent said organization for the purpose of all facility scheduling.

AAYSA assumes full responsibility for any damage done to Aubrey ISD property and for the supervision of all persons attending any event and any accidents that may occur at the AAYSA events.

Aubrey ISD agrees to allow the AAYSA to distribute three flyers to the elementary and /or middle schools during the school year.

Old Middle School Field (Football/Cheerleading, Soccer, Baseball)

AAYSA agrees to provide all field maintenance to the field (not to include area outside of the track) including mowing, watering, fertilizer for football and soccer. Baseball will maintain the area around the school field during the baseball season.

AAYSA agrees to pick up all trash and debris in and around any areas of use by AAYSA and dispose of it in a lawful manner. The President of AAYSA will be given a three day notice to provide proper maintenance if said maintenance is not performed a fee of \$50.00 will be imposed by Aubrey ISD to the AAYSA to cover maintenance cost. Major repairs to the Restrooms and Concession Building will be made by the Aubrey ISD Maintenance Department. Cost of any major repairs that are directly related to misuse or abuse will be paid for by AAYSA. The concession building, storage building, and restrooms shall be kept clean by AAYSA during the time used by the association.

Aubrey ISD agrees to provide access to the field and surrounding areas for all practices and games. In return AAYSA will provide insurance on all registered players and pay Aubrey ISD \$0.00 per player for football and \$5.00 per player for soccer and baseball for the 2011-2012 school years.

AAYSA will determine whether the fields can be played on during wet or threatening weather or due to wet grounds during the period of this agreement. Any use of the fields during the time period of this agreement shall be scheduled with the AAYSA. AAYSA may not lease or rent the fields to other entities or groups during the time of this agreement.

Basketball Gym Use

AAYSA agrees to pay Aubrey ISD the sum of \$10.00 per AAYSA registered player for the use of the Brockett, Monaco, Middle School, and Old Middle School Gyms. In Addition, AAYSA will pay Aubrey ISD \$10.00 per hour for building monitors. The building monitors are the school officials in charge and will be responsible for opening doors and locks when needed, overseeing the restrooms, and foyer areas at the facilities. Building monitors are the final authority on all matters related to school property. AAYSA will be responsible for all other gym security. The gyms will be made available Monday, Tuesday, Thursday, and Friday from 5:30pm till 8:45pm. All participants shall be out of gym area by 9:00pm. Saturday the gyms will be made available from 8am to 8pm for games. No gyms will be available on Wednesday or Sunday. All scheduling will be done through a representative from the school and a representative appointed from the AAYSA Board of Directors. All gyms will be closed during school holidays (Thanksgiving Break, Christmas Break, and Spring Break) during any School functions that would be disturbed by practice and during any State testing.

AAYSA agrees to pick up all trash and debris in and around the gyms and dispose of it in a lawful manner. A charge of \$50.00 for gym cleanup will be made to Aubrey ISD on days that the gyms are not cleaned.

Coaches can only practice at their scheduled time and location as specified by the commissioner. Make up days will only be scheduled if time and scheduling allow. Under no circumstance will any AISD staff use any AISD facility for an AAYSA team without prior written approval from the AAYSA commissioner and AISD; coaching privileges may be revoked

Brockett (Baseball and Softball Area)

Aubrey ISD agrees to provide access to the field and surrounding areas for all practices and games. In return AAYSA will provide insurance on all registered players and pay Aubrey ISD \$5.00 per player for Baseball and \$5.00 per player for Softball for the 2011-2012 school years.

AAYSA is responsible for mowing, watering, fertilization, trimming weeds, dragging and marking of the fields within the fence. Aubrey ISD is responsible for all maintenance to the areas outside the fence.

AAYSA is responsible for utilities including but not limited to water and electrical used at the baseball and softball fields:

Fields will be used on Monday, Tuesday, Thursday, and Friday from 5:00pm until 9:00pm, and the fields will be available all day on Saturday. Wednesday is available for non-mandatory practice and Sunday there can be no organized team practice. Aubrey ISD agrees to allow AAYSA to host weekend tournaments that begin on Friday and may run through Sunday.

Aubrey ISD agrees to allow AAYSA practices during spring break and when school is not in session.
