Dear Mary Ann,

The governing bodies have concluded the nomination process and have provided me with a listing of their nominees to be placed on the election ballot. The following six individuals were nominated:

- (1) Burnett, Dick
- (2) Conn, John
- (3) DeVore, Russell
- (4) Gomez, Louis
- (5) Reeves, Box

Chapter 6 of the Property Tax Code provides for the following procedures during the election process.

- (1) Prior to October 30, 2013, the chief appraiser will prepare and deliver a ballot to the presiding officer of each taxing unit that is entitled to vote.

The ballot for your taxing unit is attached hereto.

- (2) Prior to December 15, 2013, the governing body of each taxing unit shall determine its votes by resolution. The taxing unit may cast all its

votes for one candidate or may distribute the votes among any number of the five candidates. There is no provision for write-in candidates. The board of directors is a five (5) member board.

- (3) Prior to December 15, 2013, the taxing unit shall deliver its completed resolution and ballot to the chief appraiser.
- (4) Prior to December 31, 2013, the chief appraiser shall count the votes, declare the five (5) candidates who receive the largest vote totals elected and submit the results to the taxing units and the candidates.

The chief appraiser may not count votes cast for someone not listed on the official ballot.

- ( 5) The five newly elected board members will begin serving their two year term of office on January 1, 2014.

For your information and use, I have attached a schedule of the taxing units eligible to vote and their voting entitlement and the ballot for your taxing entity.
