

ATHLETIC TRAINING SERVICES CONTRACT

Unity School District and St. Croix Regional Sports Medicine



The following is an agreement for St. Croix Regional Sports Medicine (SCRSM) to supply a state registered and board certified athletic trainer to Unity High School. The Athletic Trainer will be employed by SCRSM to provide athletic training services for the Unity School District.

Purpose of Athletic Training Services

The purposes of the athletic training services are to:

- Provide immediate first aid and evaluation of athletic injuries and advise medical followup services where appropriate.
- 2. Return the injured athlete to his/her sport as soon as safely possible and prevent reinjury through the provision of athletic training services to athletes with sports related injuries.
- 3. Assist in arranging physician/physical therapy consultation when necessary.
- 4. Create opportunities for students to learn athletic training skills.
- 5. Assist Unity School District coaches with the safe implementation of performance enhancement and injury prevention training techniques and programs.

The athletic trainer will maintain records of all services provided to the school and to the individual athletes. Confidentiality of medical records will be maintained.

Athletic training services are covered under a professional liability policy paid for by SCRSM. This professional liability coverage applies to the actions of the athletic trainers and/or physical therapists as employees of SCRSM while acting within the scope of their duties and responsibilities.

Coaches and administration of the Unity School District will support the Athletic Trainer's decision when there is a question pertaining to an athlete's welfare. The Athletic Trainer works under the direction of a supervising physician.

Scope of Athletic Training Services

Athletic Training Room Coverage: Athletic training services will be provided on days designated as student contact days for the academic calendar year at Unity High School. Student contact days are defined as those days that students are required to be in school and/or student athletes have needs for athletic training services.

Game/Event Coverage: An Athletic Trainer will provide home game coverage for high school athletic competitions as agreed to by the Athletic Trainer and Unity School District. Higher risk sports will take precedence over lower risk sports at the schools we hold contracts.

Work Site and Equipment

The Unity School District will make available to SCRSM appropriate space, equipment, and supplies necessary to carry out services as described in this agreement. The services will be provided at the Unity High School Athletic Training Room and/or on the field/court/ice rink as appropriate for game coverage. The supplies necessary are to be purchased by the Unity School District. Any supplies necessary will be ordered by and approved by the Unity High School Athletic Director. The Unity School District will provide adequate athletic/activity passes to SCRSM for those healthcare professionals providing medical coverage (Athletic Trainer, Physical Therapist, Physician) at events.

Compensation

Attachment A outlines the coverage compensation model and the sharing percentage between SCRSM and the Unity School District. The baseline of 525 hours to a maximum of 600 contracted hours for each school year. Promotion/advertising costs related to programs and field advertising, along with any other service deemed appropriate by SCRSM and the Athletic Director, can be used to offset the cost of the service to the School District.

Additional coverage needs beyond the contracted hours, such as special events or tournaments, will be compensated at \$30/hour rate. SCRSM will provide a written log of hours worked on the 5th day of each month for the month prior to the Athletic Director, as requested. The Unity School District agrees to reimburse SCRSM at the end of each season for services provided.

General Provisions

Unity School District agrees to indemnify and hold SCRSM and said facilities, officers, agents and employees harmless from any and all loss, injury, damages, claims, demands, suits and judgments, including the cost of defense thereof, solely arising from negligent acts or omissions of the School District's officers, agents or employees.

SCRSM will provide general liability insurance and professional liability insurance with a limit not less than \$1,000,000 per occurrence and \$3,000,000 aggregate. SCRSM will supply the school district with documentation of such insurance and such insurance will require at least (30) days notice prior to cancellation of any such policies. SCRSM provides workers compensation coverage for the employee.

Unity High School agrees that SCRSM will be the exclusive sports medicine providers for Unity High School athletes.

Terms of Agreement

This agreement will begin on August 1st, 2013 and run through the last student contact day of 2016. The agreement will be reviewed for continuance, revision or cancellation, as requested. A written agreement signed by the both parties will be necessary to reflect continuance or revision of this agreement. Either party may terminate this agreement without cause upon ninety (90) day written notice.

It is the intent to continue a budget commitment to this program with at least the current commitment or more for additional years dependent on need. If funding sources are not found to completely pay for this service both parties have the option to discontinue this agreement.
