## Superintendent's Report to the School Board Respectfully Submitted by Gwen Carman July 14, 2025

### **Meeting Agenda Items Notes**

**Falcon View Academy Contract** We have not received any licensed applications to replace Mr. Simon to teach Life Science (Biology, 7<sup>th</sup> grade science), Chemistry and Physics in 2025-2026. As an innovative alternative, we are recommending that we hire Carly Steele who is eligible for a Tier I Life Science License (she did this in 2022-2023 in district) at 0.67 FTE. In addition, we are recommending we enter a contract with Falcon Academy (W-K's online school) to have Chemistry and Physics students receive online instruction and also hire Ms. Steel to be an Instructional Supervisor to supervise and support the students with their Chemistry (30 students) and Physics (23 students) coursework in their regular scheduled class periods.

Dr. Hanson and I have been speaking with W-K Superintendent Nels Onstad and the Falcon Academy principal about the details of this unique arrangement. The Chemistry and Physics course content would primarily be delivered via sequential online lessons and assessments. What is unique in our situation from typical online classes is that the online teacher will 'log on live' and talk with the students to update, answer questions, etc at least once weekly during their scheduled Chemistry or Physics class periods. Falcon Academy is excited to work with us as it is their goal to increase their partnerships with regional high schools to provide quality, and cost effective (for them and the districts) online instruction.

While we would prefer a 'live' teacher in our classrooms to deliver the instruction, that does not seem possible at this point. Dr. and Hanson and I agree that this is an ideal 'hybrid' model of online instruction. The students will be carefully

monitored so they are accountable to stay on track with the coursework with have 'live' support if needed. It is also an opportunity to 'teach' students *how* to successfully take online courses which are more and more common in many post secondary schools.

Financially, when we compare the district's costs from FY25 with what we are proposing for FY26 with Ms. Steel and the online contract, we are estimating a savings of \$15,000.

**Budget Amount Correction** At the June  $23^{rd}$  meeting in the official action to approve the FY26 budget the expenditure amount was incorrect – primarily due to inadvertent exclusion of the FY26 construction expenses. The approved budget handout is attached as part of the Consent Agenda with an approval item to correct the expenditure total. Note that the construction bond revenues were received in FY25, while most of the expenditures will happen in FY26 an FY27.

**Long Term Facilities Maintenance Plan** The district is required to have an approved Long Term Facilities Maintenance Plan that is submitted to MDE for approval by July 31<sup>st</sup>. This plan is a requirement in order for us the received LTFM funds. LTFM funds are specifically for costs associated with required facility testing, inspections and repairs/maintenance ("like for like"). Thank you to Business Manager Schreiber for preparing the LTFM plan for your approval.

**Strategic Plan Updates** In the Spring of 2023, the School Board and administrators worked with True North Consulting on a 2023-2025 Strategic Plan. At the July meeting, I will have the printed materials we developed that show the priorities and goals we identified. The consultants recommended to limit the goals to 2-3 years so the plan could be more manageable and be a more effective 'working document.' The attachment of June 2025 Updates shows my perspective on updates on what we have accomplished and continued focuses for 2025-2026.

## **OTHER ITEMS**

<u>Solar Panels</u> Construction is nearly completed at the high school, and waiting for MiEnergy to complete their upgrades at the high school. The panels have been delivered to the elementary school and installation will be underway. We are planning to have an 'open house/ribbon cutting' – date TBD.

Auction Planning Grafe Auction will be here July 14<sup>th</sup> and I will have an update at the Board meeting.

### Winona County Education & Lewiston – Altura School District History

I have been a member of the Winona County Historical Society Board since 2021. On July 10th, I volunteered to be at the Gainey-McCarthy Schoolhouse on the Fairgrounds in St. Charles as part of the Winona County Fair. It was a very interesting opportunity to reflect on public education, as well as interesting to talk with many people as they remembered their elementary education years. One particularly significant fact I learned is that in 1913, there were over 115 one room schoolhouses in Winona County. These began to close in the 1960s when 'education reforms' consolidated into larger community schools. For the Lewiston and Altura communities, it is my understanding that they merged in 1906 as a single 'district'. In 1956, the district celebrated a 50 year

anniversary of 'Lewiston School' making 2026 the district's 120th anniversary. Also, see photo from 1890 of a Lewiston School bus.
