ADJUNCT FACULTY AGREEMENT

THE STATE OF TEXAS COUNTY OF KINNEY

On this date, at regularly scheduled and posted meeting, came the Board of Trustees of the Brackett Independent School District, hereinafter referred to as "District". A quorum having been established, The Board proceeded to consider the appointment of the herein named individual as an adjunct faculty member of the Brackett Independent School District.

Upon consideration and vote of majority in favor to **Tyler Bobinmyer**, is hereby named as adjunct faculty member of the Brackett Independent School District subject to the following conditions and provisions of such appointment, to wit:

- 1. This appointment shall commence on the 24th day of August and end on the 4th day of June, being the end of the 2009-2010 academic year.
- 2. Adjunct faculty member shall receive no compensation, salary or remuneration from Brackett Independent School District.
- 3. Adjunct faculty member is and shall remain an employee, in good standing, of the Texas Cooperative Extension.
- 4. Adjunct faculty member shall be under the direct supervision of either the District Extension Administrator of District 10, TCE District, or Kinney County Extension Director.
- 5. Adjunct faculty member shall receive all group insurance benefits, workman's compensation insurance benefits, unemployment insurance, and any and all other plans for the benefit of Texas Cooperative Extension employees. District shall have no responsibility for any of such benefits or plans.

Adjunct faculty member shall direct the activities and participation of students of the District in sponsored and approved activities as designated from time to time by adjunct faculty member for which notice shall be give to District administrative personnel. Adjunct faculty member's activities and participation with students of the District are directed, supervised, and controlled by and through supervisory personnel of Texas Cooperative Extension pursuant to the supervisory authority of the District Extension Administrator or County Extension Director. The adjunct faculty member shall comply with all Board and District directives, state and federal laws and rules, District policy, and regulations as they exist or may hereafter be amended.

This appointment is made by Brackett Independent School District by and through the Board of Trustees of said District for the benefit of allowing voluntary student participation in programs conducted by Texas Cooperative Extension in recognition of the educational benefits arising from such participation and activities and/or directed by Texas Cooperative Extension. This appointment is made in accordance with the provisions of Section 129.21(k)(1) of the Texas Administrative Code authorizing the school to deem such participating students in attendance for foundation school program purposes.

This appointment of the herein named **Tyler Bobinmyer**, County Extension Agent(s) (TCE employee) is/are not intended nor shall be construed as a waiver of any claim or defense of sovereign or governmental immunity from liability now possessed by Brackett Independent School District or any of its employees, agents, officers, and/or board members in the performance of governmental functions.
