Level Three Hearing, grievance of James Schumann

FINDINGS AND CONCLUSIONS OF THE BOARD

- 1. The non-Chapter 21 employment contract signed on June 26, 2019 by Dr. Alejandro Flores and James Schumann, did not specify a particular job, job title, or position for Mr. Schumann, and did not set a specific amount of compensation to be paid to Mr. Schumann pursuant to the contract.
- **2.** The employment contract between Dr. Alejandro Flores and South San Antonio ISD (SSAISD) signed on October 3, 2018, did authorize Dr. Flores, in his capacity as Superintendent, to hire district employees.
- 3. The employment contract between Dr. Alejandro Flores and South San Antonio ISD (SSAISD) signed on October 3, 2018, did not authorize Dr. Flores, in his capacity as Superintendent, to vary the terms of the standard SSAISD employment contracts for district employees, or to insert any contractual provision in conflict with existing policies adopted by the District's Board of Trustees. Nor could the Superintendent take actions which were inconsistent with the provisions of the applicable compensation plan adopted by the Board.

- **4.** Other than the two contracts approved for James Schumann and his mother, Bettinae Kaiser on June 26, 2019, Dr. Flores never approved any contract which was inconsistent with the District's adopted contract forms.
- 5. At all times relevant to this grievance, Tex. Educ. Code Section 11.201(d)(2), SSAISD Board Policy DK (Local), and the employment contract signed on June 26, 2019 by Dr. Flores and James Schumann, James Schumann was subject to assignment and reassignment by the Superintendent.
- **6.** Interim Superintendent Dolores Sendejo had authority to reassign James Schumann from the position of Chief of Staff to the position of Transportation Supervisor, effective December 6, 2019, as shown in Attachment C to the Level One grievance statement filed by James Schuman, which is the subject of this grievance.
- 7. At all times relevant to this grievance, SSAISD Board Policy DEA (Local), required the Superintendent or designee to pay employees according to the compensation plan approved by the District's Board of Trustees.
- **8.** At all times relevant to this grievance, DEA (Local) required the Superintendent "to implement the compensation plan," and "to determine pay adjustments for individual employees, within the approved budget following established within the approved budget following established procedures."
- 9. As of December 5, 2019, under the existing District compensation plan adopted by the Board, the position of Transportation Supervisor was classified as Pay Grade MSB—Auxiliary Scale, for a 240 day work schedule, to be paid an annual salary of \$66,931.00 for working the entire 240 days, or prorated at the daily rate of \$278.88.
- 10. The Interim Superintendent was authorized under DEA (Local) and the compensation plan adopted by the Board, upon the reassignment of Mr. Schumann to the position of Transportation Supervisor, to reduce the compensation of James Schumann to the rate of pay for this position in the compensation plan approved by the Board.
- **11.** The non-chapter 21 contract signed by Dr. Flores and James Schumann on June 26, 2019, contained the following language in Paragraph 1:

. . . ("District") agreed to employ Employee in a noncertified position or under a local District teaching permit, subject to assignment and reassignment by the Superintendent, reassignment by the Superintendent, under no circumstances will reassignment negatively alter

established salary, with the initial assignment being as follows:

Professional Position, Noncertified Administrator Position or Other (specify)

12. This same employment contract provided as following in Paragraph 6.1:

The District shall pay you according to the annual compensation plan adopted by the Board. Your salary includes consideration for all assigned duties, responsibilities, and tasks, regardless of the actual number of hours or days . . .

- 13. James Schumann was at all times paid for his work as Transportation Supervisor, starting December 6, 2019, as provided in the District compensation plan approved by the Board.
- 14. To the extent that the provisions of Paragraph 1 of the employment contract of James Schumann signed June 26, 2019 conflict or are inconsistent with Board Policy DEA (Local), or conflict or are inconsistent with the provisions of the District's compensation plan approved by the Board, the provisions of the Board-approved compensation plan and of Board Policy DEA (Local), are controlling.
- **15.** James Schumann received the amount of compensation for his services as Transportation Supervisor for SSAISD, as authorized in the applicable compensation plan for the 2019-20 school year, adopted by the District's Board of Trustees.
- 2. Reconvene into open session: consideration and possible approval of items discussed in closed session

Mr. Rodriguez made a motion: I would like to move that we hire the following coaches for West Campus High School, head football coach, Leandro Gonzalez, head boys basketball coach, Casey Garcia, head girls basketball coach, Amado Luis, Mrs. Alderete seconded, and the Board of Trustees voted 6/0 to approve. Motion passed.
