2025-2026 TAX LEVY ORDER AND RESOLUTION

AN ORDER AND RESOLUTION FIXING AND LEVYING SCHOOL DISTRCT AD VALOREM TAXES FOR THE GOOSE CREEK CONSOLIDATED INDEPENDENT SCHOOL DISTRICT OF CHAMBERS AND HARRIS COUNTY, TEXAS, FOR THE FISCAL YEAR 2025-2026, AND DIRECTING THE ASSESSMENT AND COLLECTION THEREOF.

WHEREAS, the Board of Trustees of the Goose Creek Consolidated Independent School District finds that the tax for the fiscal year 2025-2026 hereinafter levied for current expenses of the District and the general education of students within said District and for the improvement of the District and its property must be levied to provide the revenue requirements of the budget for the ensuing year; and

WHEREAS, the Board of Trustees of said District further finds that the taxes for the fiscal year 2025-2026, hereinafter levied therefore, are necessary to pay interest and to provide the required sinking fund on outstanding bonds of the district issued for school purposes, and on bonds proposed to be issued for such purposes during the ensuing year.

NOW, THEREFORE, BE IT ORDAINED AND RESOLVED by the Board of Trustees of the GOOSE CREEK CONSOLIDATED INDEPENDENT SCHOOL DISTRICT OF CHAMBERS AND HARRIS COUNTY, TEXAS, that the tax rate for the 2025-2026 tax year shall be as follows:

MAINTENANCE AND OPERATION RATE \$ 0.7450/\$100 valuation INTEREST AND SKINING RATE \$ 0.3250/\$100 valuation TOTAL OF ADOPTED TAX RATES \$ 1.0700/\$100 valuation

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.06 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$22.10.
