**1. Facilities -**

- a. HASS reporting has been approved and is now posted on our website. We are in compliance.
- b. Community partners kindly dedicated labor and materials to lay 2 - 20x20 ft. concrete slabs outside the CTE building. They will house our sawmill and our new greenhouse for the developing programs. Thank you for this incredible improvement to our campus and CTE programs.
- c. ODE delivered our site assessment report with recommendations for campus security as presented in January. We also received our 400 page evaluation report with guidance on a 5-year to 30-year improvement plan on our facilities. This binder can be reviewed at the DO. is working on prioritizing projects and working with administration on funding avenues for this work.
- d. 2026 TAP Grant for Roof Structure Evaluation has been submitted to ODE. ZCS and Integrity Solutions held a zoom meeting with me last week to review new insurance updates and the importance of a structural evaluation moving forward. Based on our plant size, we are in the \$10,000 grant pool. Awards should be named this spring and we will have ZCS conduct this assessment should we be awarded the funding.

**2. Schedules and Systems**

- Title (RTI) is underway and our master schedule rebuild for semester 2 has been completed. RTI is more fully functional for elementary and we have also added a section for middle school and high school. Teacher teams have been meeting to review our 2nd diagnostic data, grouping students based on tiers 2 and 3 and aligning interventions during our core reading and math sections.
- Informal observations are still underway for the second round.
- Instructional Rounds begin this month as our January schedule was too full. K-12 focus is on differentiation and center work.
- 2026-27 Calendar options were developed based on staff input. Two options were presented and the staff unanimously agreed to Calendar A - presented in New Business.
- MAC training for all staff is underway with our first survey in March.
- SpEd IA training for effective and collaborative progress monitoring took place for the district this past week. We are regrouping to more efficiently and effectively serve our students. We are excited to work through a more cohesive vision in this area.
- Cyclical Monitoring Cohort A - completed in January. Review by ODE has findings in the area of student-level noncompliance. Training webinars are scheduled for Feb. 17th with an action plan to get us in compliance under the guidance of our district compliance specialist. The deadline for this work is March 21, 2026.

- Infexion Leadership Collaborative work is in progress. Aligning district strategic planning with school community input is set for April.
- Outdoor School grant funding has been secured, though less than prior years. Students in 6th grade are getting their paperwork in and planning meetings are being prepared, currently.

#### Fiscal

- Budget season is beginning. Data sheets have been collected from staff and departments to assist in our planning.
- Grant reporting for Qtr. 2 is nearly complete.
- The fiscal team is working to evaluate our resignations and how some roles can be absorbed and assessing cost savings while ensuring services are provided appropriately.
- Contracted services are also being evaluated and reduced where appropriate and without cutting positions.
- LaHo online platform had to be reinstated as too many students and families were struggling with the inefficiencies of the zoom system. The annual subscription for this platform saved the district \$14,000 each year. However, the success of our students and their families was worth far more than the savings. In order to keep our families enrolled and successful at LaHo, we reinstated the online platform.
