The number of votes available to your tax unit is shown on the second page of the resolution. The governing body may cast votes as they desire among the five nominees.

The Texas Property Tax Code requires that the governing body of each taxing unit entitled to cast at least five percent of the total votes must determine its vote by resolution adopted at the first or second open meeting of the governing body that is held after the date the chief appraiser delivers the ballot to the presiding officer of the governing body. The governing body must submit its vote to the chief appraiser no later than the third day after the resolution is adopted.
