The President announced that the next item of business before the Board of Education was the consideration of a resolution abating a portion of the tax heretofore levied for the year 2025 to pay debt service on the District's outstanding General Obligation Refunding School Bonds, Series 2020B.

Whereupon Member _____ presented and the Secretary read by title a resolution as follows, a copy of which was provided to each member of the Board of Education prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating a portion of the tax heretofore levied for the year 2025 to pay debt service on the General Obligation Refunding School Bonds, Series 2020B, of School District Number 131, Kane County.

WHEREAS, the Board of Education (the "Board") of School District Number 131, Kane County, Illinois (the "District"), by resolution adopted on the 21st day of January, 2020 (as supplemented by a notification of sale, the "Resolution"), did provide for (i) the issue of \$20,805,000 General Obligation Refunding School Bonds, Series 2020B (the "Bonds"), and the levy of a direct annual tax to pay the principal of and interest on the Bonds (as partially abated by a related direction for abatement of taxes, the "Pledged Taxes"), and (ii) the establishment of a bond fund for the repayment of the 2020B Bonds (the "2020B Bond Fund"); and

WHEREAS, the Board has determined and does hereby determine that the District has funds in the amount of \$350,000 available and on deposit in the 2020B Bond Fund (the "Available Funds") and that it is necessary and in the best interests of the District to use the Available Funds in the 2020B Bond Fund for the purpose of paying the principal of and interest on the Bonds; and

WHEREAS, it is necessary and in the best interests of the District that the District abate a portion of the Pledged Taxes levied for the year 2025 by the amount of the Available Funds:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of School District Number 131, Kane County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this resolution by this reference.

Section 2. Abatement of Tax. The Pledged Taxes levied for the year 2025 shall be abated by the amount of the Available Funds, and the amount of the Pledged Taxes levied in Section 9 of the Resolution for the year 2025, the amount of the Pledged Taxes previously abated for said year, the additional amount of the Pledged Taxes to be abated for said year and the remainder of the Pledged Taxes levied which is to be extended for said year are as follows:

Section 4. Severability. If any section, paragraph, clause or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

Section 5. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this Resolution shall be in full force and effect forthwith upon its adoption. Adopted November 3, 2025.
