JUSTIFICATION: Pricing in accordance with Reference 1804 – Interlocal Agreement with The Cooperative Purchasing Network (TCPN), sponsored by Region IV Education Service Center, pursuant to the Texas Interlocal Cooperation Act, Chapter 791, Texas Government Code. The purpose of this cooperative is to obtain substantial savings for member school districts and public entities through volume purchasing.

Pricing in accordance with Reference 1831 – Interlocal Agreement with the Texas Local Government Statewide Purchasing Cooperative (Buyboard) pursuant to the Texas Interlocal Cooperation Act, Chapter 791, Texas Government Code. Membership was approved by the Board of Trustees on October 23, 2001. The purpose of this cooperative is to obtain substantial savings for member school districts and public entities through volume purchasing.

Pricing in accordance with the State of Texas Department of Information Resources (DIR) GoDIRect Program. Texas Government Code, Chapter 2054 established the Department

of Information Resources (DIR) which is responsible for combining information technology purchases and establishing cooperative contracts for state agencies, universities and their boards, school districts, political subdivisions, and the citizens of Texas. The District is eligible to participate as a cooperative member of the Texas Procurement and Support Services (TPASS).

State of Texas Department of Information Resources Contracts #DIR-SDD-509, #DIR-SDD-512, #DIR-SDD-1662, and #DIR-SDD-1673.

Pricing in accordance with the State of Texas Term Contract #TPASS 985-L2. Texas Education Code, Subchapter B, Section 44.031, allows the District to make purchases utilizing contracts established by Texas Procurement and Support Services (TPASS).
