**Calendar Committee Report**  
**February 22, 2016**

The Calendar Committee met on January 19, 2016 and developed a set of criteria on which to adjust next year's calendar. A survey was sent out with over 600 responses as to staff, parent, patron, and student preferences based on those criteria. The calendar committee met again and developed a number of different calendars that met those criteria. A second survey was again sent out with over 600 respondents which pointed toward two of the five calendars that were developed. Here are the results of that second survey given as percentage of respondents:

Summary narrative:

36% of all respondents chose calendar B as did 41% of all parents.

67.7% of all respondents chose calendar A1 as either their first or second choice with parents evenly split on A1 and B as either their first or second choice

At their final meeting on February 9<sup>th</sup>, the Calendar Committee voted and with a vote of 8 to 6 chose calendar A1 as their recommendation to the board with a few minor adjustments. The adjusted Calendar A1 has now become calendar A and it and calendar B are being presented to the board for your consideration (attached).
