Here are few highlights of what we achieved together this past year.

- Our school advisory committee adopted new bylaws this year, and added a Special Education
 Director to the group. This group meets monthly and provides important input and guidance for
 LCSC.
- ✓ LCSC made the Star Tribune's Top 150 workplace list for the second year in a row. This award is based on surveys of our staff. We are proud of our service-driven, member-focused team at LCSC.
- ✓ Together we hosted an effective day at the legislature in support of a strong educational platform. Our voices made a difference! LCSC continues to work with our national partners to advocate for strong education support.
- ✓ The Education Services Department worked with local literacy leaders to start the regional Literacy Action Network.
- ✓ The Express Marketplace, a one-stop online purchasing site with guaranteed savings from multiple vendors, passed the 1 million dollar mark after opening just over a year ago. This success translates into additional savings in time and money for your district.
- Our Technology group added two new staff members. In addition, we are offering data backup services and iPad repair services.
- ✓ LCSC continues to spearhead the statewide Charting the C's Special Programs Conference where attendance hit 680 educators across the state. The Paraprofessional Conference attracts over 300 attendees from our region alone.
- ✓ The Fresh Connect Food Hub completed its pilot year and will continue because of overwhelming support from participating districts.
