### FCS Budget:

Being a Focus school has been a challenge

- Increase in FTE from 16 to 18 due to enrollment and add additional 1.0 FTE Instructional Coach
- Moved monies to cover STAR testing and increase in copy machine costs
- Student Support position moved to Behavior Specialist position
- Moved from district to cover fielding field trips
