A RESOLUTION OF THE CITY COUNCIL OF THE TOWN OF HORIZON CITY, AUTHORIZING PARTICIPATION WITH THE STATE OF TEXAS, THROUGH THE OFFICE OF THE ATTORNEY GENERAL, IN THE LATEST GLOBAL OPIOID SETTLEMENTS; APPROVING AND RATIFYING SETTLEMENT PARTICIPATION FORM SUBMISSION TO THE ATTORNEY GENERAL’S OFFICE; AUTHORIZING THE EXECUTION OF ALL RELATED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the Town of Horizon City (the “City”) obtained information indicating that drug retailers, along with certain drug companies, corporate affiliates, parents, subsidiaries, and such other defendants as may be added to the litigation (collectively, “Defendants”) engaged in fraudulent and/or reckless marketing and/or distribution of opioids that have resulted in addictions and overdoses; and

WHEREAS, these actions, conduct, and misconduct have resulted in significant financial costs to the Town; and

WHEREAS, on May 13, 2020, the State of Texas, through the Office of the Attorney General, and a negotiation group for Texas political subdivisions entered into an Agreement entitled Texas Opioid Abatement Fund Council and Settlement Allocation Term Sheet (hereafter, the Texas Term Sheet) approving the allocation of any and all opioid settlement funds within the State of Texas. The Texas Term Sheet is attached hereto as Exhibit “A”; and

WHEREAS, on November 09, 2021, the City approved the Texas Term Sheet via Resolution; and

WHEREAS, Counsel and the State of Texas have recommended that the City Council of the Town of Horizon City support the approval and submission of the latest settlement participation forms pertaining to the new Purdue Direct Settlement, and the Alvogen, Amneal, Apotex, Hikma, Indivior, Viatris (Mylan), Sun, and Zydus Settlement. These forms are attached hereto as Exhibit “B.”

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF TOWN OF HORIZON CITY, TEXAS THAT:

SECTION 1. The findings set forth in the recitals of this Resolution are hereby found to be true and correct and are hereby adopted as findings of the City Council and are incorporated into the body of this Resolution as if fully set forth herein.

SECTION 2. The City supports and ratifies the approval and submission of the latest settlement participation forms pertaining to the Purdue Direct Settlement and the Alvogen, Amneal, Apotex, Hikma, Indivior, Viatris (Mylan), Sun, and Zydus Settlement, attached hereto and incorporated herein as “Exhibit B.”

SECTION 3. There is a substantial need for repayment of opioid-related expenditures and payment to abate opioid-related harms in and about the City.

SECTION 4. The City supports and reaffirms the allocation method for opioid settlement proceeds as set forth in the STATE OF TEXAS AND TEXAS POLITICAL SUBDIVISIONS’ OPIOID ABATEMENT FUND COUNCIL AND SETTLEMENT ALLOCATION TERM SHEET, attached hereto as Exhibit A.

SECTION 5. The City understands that the purpose of these participation forms and the Texas Term Sheet is to permit collaboration between the State of Texas and Political Subdivisions to explore and potentially effectuate resolution of the Opioid Litigation against Pharmaceutical Supply Chain Participants as defined therein.

SECTION 6. The City also understands that an additional purpose is to create an effective means of distributing any potential settlement funds obtained under this Texas Term Sheet between the State of Texas and Political Subdivisions in a manner and means that would promote an effective and meaningful use of the funds in abating the opioid epidemic in this City and throughout Texas.

SECTION 7. The City Council approves and ratifies the Mayor or his designee’s execution and submission of all necessary related documents. This Resolution shall become effective immediately from and after its passage.
