

MINUTES of a regular public meeting of the Board of Education of Rock Island School District Number 41, Rock Island County, Illinois, held at the Administration Building, 2000 7th Avenue, Rock Island, Illinois, in said School District at 6:00 o'clock P.M., on the 10th day of December, 2024.

The President called the meeting to order and directed the Clerk to call the roll.

Upon the roll being called, the following members were physically present at said location:

The following members were allowed by a majority of the members of the Board of Education in accordance with and to the extent allowed by rules adopted by the Board of Education to attend the meeting by video or audio conference:

No member was not permitted to attend the meeting by video or audio conference.

The following members were absent and did not participate in the meeting in any manner or to any extent whatsoever:

The President announced that the next item of business before the Board of Education was the consideration of a resolution abating the taxes heretofore levied for the year 2024 to pay debt service on the General Obligation School Bonds (Alternate Revenue Source), Series 2020, of the District.

Whereupon Member _____ presented and the Clerk read by title a resolution as follows, copies of which were available to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating the taxes heretofore levied for the year 2024 to pay debt service on the General Obligation School Bonds (Alternate Revenue Source), Series 2020, of Rock Island School District Number 41, Rock Island County, Illinois.

WHEREAS, the Board of Education (the “*Board*”) of Rock Island School District Number 41, Rock Island County, Illinois (the “*District*”), by resolution adopted on the 12th day of May, 2020, as supplemented by a notification of sale (together, the “*Resolution*”), did provide for the issue of \$14,700,000 General Obligation School Bonds (Alternate Revenue Source), Series 2020, of the District (the “*Bonds*”), and the levy of direct annual taxes sufficient to pay the principal of and interest on the Bonds (the “*Pledged Taxes*”); and

WHEREAS, the Resolution established a special fund of the District known as the “Alternate Bond Fund of 2020” (the “*Bond Fund*”) for the repayment of the Bonds; and

WHEREAS, the Board hereby determines that Pledged Revenues (as defined in the Resolution) or other lawfully available funds are available and on deposit in the Pledged Revenues Account of the Bond Fund in an amount sufficient to pay principal of and interest on the Bonds when due, so as to enable the abatement of all of the Pledged Taxes levied for the year 2024; and

WHEREAS, the Board hereby further determines that it is necessary and in the best interests of the District that the Pledged Taxes levied for the year 2024 to pay the Bonds be abated in their entirety:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of Rock Island School District Number 41, Rock Island County, Illinois, as follows:

Section 1. Abatement of Tax. The Pledged Taxes levied for the year 2024 in the Resolution are hereby abated in their entirety.

Section 2. Filing of Resolution. Forthwith upon the adoption of this Resolution, the Clerk of the Board shall file a certified copy hereof with the County Clerk of Rock Island County, Illinois, and it shall be the duty of said County Clerk to abate the Pledged Taxes levied for the year 2024 in accordance with the provisions hereof.

Section 3. Effective Date. This Resolution shall be in full force and effect forthwith upon its adoption.
