July 28, 2009 FY10 BUDGET PUBLIC HEARING

The Board of Trustees of the Tupelo Public School District convened in a duly called special meeting of the school board held in open session at approximately 5:00 p.m. on Tuesday, July 28, 2009, at the Hancock Leadership Center, 1920 Briar Ridge Road, Tupelo, Mississippi.

Finance Director Linda Pannell presented the proposed 2009-2010 Tupelo Public School District Budget. The total anticipated revenue for 2009-2010 is projected to be \$82,992,001 and the total expenditures for the 2009-2010 school year are budgeted at \$85,267,904.

A copy of the proposed budget is marked EXHIBIT 1 and included in the Exhibit Book of this meeting date.

At this point, Dr. Tutor opened the meeting for questions from the floor by explaining that each individual would be allowed to ask one question at a time on a rotating basis until all participants had the opportunity to present a question or make a statement.
