The following members were absent and did not participate in the meeting in any manner or to any extent whatsoever: The President announced that the next item of business before the Board of Education was the consideration of a resolution abating the taxes heretofore levied for the year 2019 to pay debt service on the General Obligation School Bonds (Alternate Revenue Source), Series 2019, of the District. Whereupon Member presented and the Secretary read by title a resolution as follows, copies of which were available to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating the taxes heretofore levied for the year 2019 to pay debt service on the General Obligation School Bonds (Alternate Revenue Source), Series 2019, of Community Unit School District Number 8, Christian, Shelby and Montgomery Counties, Illinois.

WHEREAS, the Board of Education (the "Board") of Community Unit School District Number 8, Christian, Shelby and Montgomery Counties, Illinois (the "District"), by resolution adopted on the 25th day of February, 2019 (the "Resolution"), did provide for the issue of \$1,500,000 General Obligation School Bonds (Alternate Revenue Source), Series 2019, of the District (the "Bonds"), and the levy of direct annual taxes sufficient to pay the principal of and interest on the Bonds (the "Pledged Taxes"); and

WHEREAS, the Resolution established a special fund of the District known as the "Alternate Bond Fund of 2019" (the "Bond Fund") for the repayment of the Bonds; and

WHEREAS, the Board hereby determines that lawfully available funds are or will be available to pay principal of or interest on the Bonds when due in the next bond year (being the twelve-calendar month period beginning on June 2 of the calendar year in which the Pledged Taxes levied for the year 2019 are to be collected and ending on June 1 of the subsequent calendar year), so as to enable the abatement of all of the Pledged Taxes levied for the year 2019; and

WHEREAS, the Board hereby further determines that it is necessary and in the best interests of the District that the Pledged Taxes levied for the year 2019 to pay the Bonds be abated in their entirety:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 8, Christian, Shelby and Montgomery Counties, Illinois, as follows:

Section 1. Abatement of Tax. The Pledged Taxes levied for the year 2019 in the Resolution are hereby abated in their entirety.

Section 2. Filing of Resolution. Forthwith upon the adoption of this Resolution, the Secretary of the Board shall file a certified copy hereof with the County Clerks of Christian, Shelby and Montgomery Counties, Illinois, and it shall be the duty of said County Clerks to abate the Pledged Taxes levied for the year 2019 in accordance with the provisions hereof.

Section 3. Effective Date. This Resolution shall be in full force and effect forthwith upon its adoption.
