SUMMARY:

This item requests approval of CSP 090129-CN for Child Nutrition Commodity Processing for the 2009-10 school year.

BOARD GOAL:

VI. Growth and Change...a. review and adjust policies and procedures effectively to address the challenges of rapid growth and changing demographic characteristics while maintaining and enhancing our strong sense of community

PREVIOUS BOARD ACTION:

February 12, 2008 the Board approved the 2008-09 bid as recommended.

BACKGROUND INFORMATION:

Bidders submit all of the services they provide. However, our district does not use all of the types of processing. The types used are noted on the summary sheets.

Proposals were submitted by Advance, JTM Provisions Co, King's Command, Tyson, RSW Culinary Standards, MCI Foods, Land O Lakes, Schreiber Foods, East Side Entrees, Jennie-O, King's Delight, Pilgrim's Pride, Ling's, Con-Agra, Nardone Brothers, Schwan, RSW dba Culinary Standards, Simplot, Red Gold, and Wawona Frozen Foods.

Pricing was submitted as a Fee for Service or Net off Invoice. It will depend upon the commodities actually processed as to how much will be spent.

Pricing was reviewed and each category of processing was given to the processor with the best over-all pricing.

SIGNIFICANT ISSUES:

Commodity Processing for the 2009-10 year must be approved by the end of February 2009.

The best over all pricing was submitted as follows;

Advance – Beef, Jennie-O – Turkey, Tyson Food – Chicken, ConAgra – Mozzarella Cheese (from 2008-09), Simplot – Potatoes, Schreiber Foods – Barrel Cheese.

15,000 lb of Tomato Paste will be processed through the Prospering Pals Cooperative to make up a full truck with Red Gold. No one school has enough paste to make a full truck.
