The course also discussed the audit process should DPS decide to audit organizations that use their databases. Under Senate Bill 9, school districts have been given access to criminal history information that is not available to any other type of employer. KISD is pleased to report that Human Resources is in compliance with the guidelines and believe, if audited, will receive a 100% rating.
