#### CALL MEETING TO ORDER AND BOARD PROCEDURES - LeeAnn Larsen

School Board Chair LeeAnn Larsen called the Business Meeting to order at 5:30 p.m. Linda Degman led the group in the Pledge to the Flag.

Chair LeeAnn Larsen asked for changes to the agenda. There were none but Mary VanderWeele gave a heads up that there was an updated item, Metered Mail Services, under Public Contracts.

#### PUBLIC COMMENTS

**Everett Johnsen** – Everett is a student in the District and spoke about the recent Superintendent's raise.

**Chris Johnsen** – Chris is a parent in the District and spoke about the recent Superintendent's raise. **Becky Jarvis** – Becky is a parent and business owner in the district and spoke about the recent Superintendent's raise.

**Rosa Rothenberger** – Rosa spoke about School Library Programs and how BSD students are at a disadvantage. She would like to know the short and long term goals for the library programs, what is the process to add back librarians and will the district be surveying the program.

**Joe Rayhawk** – Joe has had five children attend Beaverton schools. He is concerned about a large earthquake hitting the area. He would like to instigate a system that would alert the District sooner if an earthquake should hit our area.

**Lloyd Bernstein** – Lloyd welcomed the new board members. He is a parent in the community and active with *Stand for Children*. His suggestions for the Board included: 1) Consider having someone from the School Board replace Karen Cunningham's position on the OSBA Board; and 2) Legislative affairs and issues, be more proactive, particularly with PERS reform.

LeeAnn commented on the remarks made regarding the Superintendent's raise. The last two years have been very difficult and Supt. Rose has done an excellent job both in the District and at the state level. He has made donations and will continue to do so. The board unanimously offered the contract fully expecting him to accept the offer. He has helped set the direction for the District's future success.

July 8, 2013

Mary VanderWeele thanked Everett and Chris Johnsen and Becky Jarvis for their comments. At the end of the day, although there is disagreement, the Board appreciates the feedback but does ask that people consider a few other things.

The job of the superintendent is one of the hardest in the state and requires someone to do a lot of things; CEO of a multi-million dollar organization, a politician and they need to be a cutting edge instructional leader. Good superintendents are really hard to find. When the School Board conducted the superintendent search two years ago they looked outside of Oregon and interviewed candidates from Michigan, California and Colorado. The superintendent's job is the number one priority for the School Board and they want the very best for all students. Teachers and textbooks are important also, but just like teachers have the most impact in classrooms, Dr. Rose has the most impact for the 39,000 students in our District. Even though we cannot afford to pay him what the average superintendent would make in a large district in the U.S. the Board wanted to get a little closer to that and reward him for the very, very hard job that he has.

Regarding people asking him to donate the raise back to the school district. It is OK to disagree with School Board for that decision but it is not OK for people to tell Dr. Rose what to do with his salary anymore than it is to tell me what to do with my salary or anyone else in this room tonight. What he does with his well-deserved salary is his choice. Dr. Rose has donated a significant amount of time and money to the District. She also recognized the burden of taxes and that not all needs are being met for our students.

Linda Degman nominated Jeff Hicks for Board Vice-Chair. Jeff has been on the board for 8 years and brings a wealth of knowledge and was a teacher for 18 years. He also attended school in Beaverton and spends a lot of time visiting our schools. Susan Greenberg seconded the nomination. The Board voted unanimously.



# Welcome and Overview of the Day – Mary VanderWeele and Lori Emerick

Mary welcomed everyone and explained that today would be informal and spent on Board goal setting and team building. She introduced Lori Emerick from Nike and her involvement with the School District over the last few years.

Lori began with a video on What is a Good Leader? The video interviewed students about what they thought a good leader is and how they should lead.

Jeff Hicks shared a timeline of the District going back to 2003. He listed people and events that have shaped the future of the District. Board members were then asked to share additional items that they felt should be added to the timeline and explain why they added.

- **Options schools** A whole change in philosophy in education and why is it offered to some students and not other students?

- Disciplinary Handbook major changes made to it and how it has evolved into a resource guide.
- Arts for Education fascinating that it was such a huge grant and that it would affect so many schools. Disappointment that it did not trickle down to all schools.
- Charter Schools Approval of first charter school.
- Statistics on disproportional referrals to students of color.
- **Cutting sports** some community members are still unhappy about sports that were cut. Funded vs. club.
- **Massive reduction in force** A wake-up call for the community as layoffs to this extent had never been made in Beaverton.
- Clarifying long term resources and values
- **Media reporting** tends to make us "react" to things. Media is changing nationally due to costs, readership, etc.
- Graduation Requirements
- Measures/what do we value, what do we measure?
- Community Involvement discontinuing LSC's and looking at next steps
- Transfers Board involvement and communication. BEA involvement and contracting.
- Decisions/rights
