The Collin County Community College District Board of Trustees conducted a called meeting on August 16, 2016, in Board Room 139, Collin Higher Education Center, with Chairman J. Other attendees included District President H. Neil Matkin, Collin College administrators, faculty, staff, and community members.

CALL TO ORDER

Chairman Collins called the August 16, 2016, meeting of the Board of Trustees of Collin County Community College District to order at 5:02 p.m. in the Board Room 139, at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

2016-8-3-1 Second Public Hearing on Proposed 2016 Tax Rate

2016-8-3-2 Presentation of the Proposed 2016-2017 Budget

Acting Vice President of Administrative Services/Chief Financial Officer Ken Lynn presented the proposed 2016-2017 Budget to the Board of Trustees. He reviewed the budget detail in a slide presentation. The proposed budget for Fiscal Year 2016-2017 was presented as follows:

Current Funds (operating, auxiliary, and grants/contracts) - \$215,495,662; Building Fund expenditures - \$33,862,000; General Obligation and Revenue Debt Services funds - \$4,555,937; Total Budget being \$253,913,599 with said funds to be appropriated to the various expenditure accounts as outlined in the budget documentation distributed to each board member for review.

In answer to Mr. Wainwright's questions regarding the cost of benefits, Mr. Lynn said the cost of insurance and other benefits is increasing. He also noted the changes in budget due to the payoff of bonds.

No action was required nor taken.

2016-8-3-3 Public Hearing on 2016-2017 Proposed Budget

A public hearing was held on the proposed 2016-2017 Budget for Collin County Community College District as an opportunity for the public to make comment regarding the college's proposed budget for the upcoming fiscal year.

Chairman Collins opened the public hearing related to the 2016-2017 Proposed Budget at 6:04 p.m. There being no comment, Chairman Collins closed the public hearing at 6:05 p.m.

President Matkin said there would be time for questions and discussion regarding the proposed 2016-2017 Budget prior to the Board's consideration to approve on August 23.

Mr. Lynn's presentation was forwarded to the Board of Trustees via email for their information.

In answer to Mr. Hardin's question regarding salaries, Dr. Matkin said staff salaries were reviewed and adjustments made in a comprehensive study of salaries last year. He said he is currently working on issues and salary factors regarding faculty and that he intends to come back to the Board in the near future with a recommendation once the analysis is completed. President Matkin said money had been set aside in the 2016-2017 budget in regard to faculty salaries.

<u>2016-8-3-4 Approval of Date, Time and Place for Adopting 2016 Tax Rate</u>
The Board of Trustees set the time, date, and place for adopting the 2016 Tax Rate.

On motion of Mr. Orr, second of Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the date, time, and place for adopting the 2016 Tax Rate and publicly announced that the meeting to adopt the 2016 Tax Rate will be held on Tuesday, August 23, 2016, at 7:00 p.m. in Board Room 139 at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.
