Presentations/ Recognitions Three Denton ISD students were selected to perform with the 2025 Texas Choral Directors Association (TCDA) Elementary Honor Choir, an elite ensemble featuring top vocalists from across the state. The choir is composed of approximately 150 outstanding students who have completed grades 4–6 and are chosen through a rigorous audition process involving hundreds of applicants statewide.

Denton ISD welcomed over 7,000 families at two Back to School Fairs held earlier this month. The events took place at LaGrone Academy on August 2 and Braswell High School on August 9, providing essential services and resources to help students start the year with confidence.

Public Hearing on 2025-2026 Tax Rate Jennifer Stewart, Executive Director of Budget, provided the Board of Trustees with projected revenue information, based on 2025-2026 budget elements, to assist with the process of adopting a tax rate for the 2025-2026 fiscal year. The tax rate affects various levels of local and state funding, depending on the rate adopted. If the District adopts a tax rate above the voter approved tax rate, the District is required to hold an automatic voter approved tax ratification election to ratify the current year's tax rate.

Discussion of Athletics Update

Dr. Chivonne Kiser, Asst. Director of Athletics provided an overview of Denton ISD's athletic programs for the 2024-2025 school year. There were 8,632 total athletes in grades 7-12, 20 programs at the high school level, 8 programs at the middle school level, 4 state champions, 3.75 cumulative GPA for Varsity student athletes, \$1.9 million in scholarship money, 835 scholar athletes, 25 1st team all-state qualifiers, 210 1st team all-district or regional qualifiers, 6 district champions, and 89 academic all-state recipients.

The department provided athlete safety efforts, data, and guidelines and provided an overview of the "Texas Way" initiative, an effort led by UIL and the Texas High School Coaches Association to promote sportsmanship, integrity, and character across all athletic programs.

Discussion of Fine Arts Update

Eddy Russel, Director of Fine Arts, provided the departmental activity for the 2024-25 school year including student enrollment data, awards, and goals achieved. There were over 50 Fine Arts Clubs that served students before or after school over the 2024-2025 school year.

Extra-Curricular Fine Arts Clubs and Activities included: Marching Band, Drill Team, Dance Club, Step Team, Ballet Folklorico, Choir, Honor Choir, Show Choir, Instrumental Club, Drum Club, Jazz Band Club, Mariachi Club, Fiddle Club, Color Guard Club, Art Club, National Art Honors Society, Thespian Society, Theatre, Drama Club, Theatre Club, Yearbook, and Cheer.

During the Fine Arts Signing Day there were 54 seniors signed to collegiate Fine Arts programs and over \$6 million in Fine Arts scholarships were awarded. Denton ISD for the 18th consecutive year has been named one of U.S. 2025 "Best Communities for Music Education" by the NAMM Foundation. Denton ISD was named a 2024-25 Exemplary District of Distinction by the Texas Education Theatre Association and named a 2024-25 Premier Community for Theatre Education by Texas Thespians.

2025-2026 Enrollment Update Dr. Lacey Rainey, Assistant Superintendent for School Leadership & Academic Programs provided the Board of Trustees with the current district enrollment as of August 12, 2025. The analysis of Denton ISD's enrollment data allows the district to ensure that all campuses remain in compliance with the state's class size requirements.
